Karen Thompson and Sharon Kowalski still need your help, Seattle for Karen Thompson and Sharon Kowalski. The completion of their legal battle means the start of a more private campaign to find meaning in a relationship permanently transformed by a tragic accident and years of enforced separation. In a recently published interview with partners magazine for gay and lesbian couples, the women recounting the history of their relationship and Thompson's recent efforts to return Kowalski to a home she built to accommodate the disabled woman special needs. Thompson 44 and Kowalsky 35 have been partners for 12 years, they were separated for eight of those years when Kowalski was disabled in a car accident caused by a drunk driver. The separation was forced by Kowalski parents and enforced by the Minnesota courts until the Minnesota Supreme Court upheld the lower court decision awarding Thompson's legal guardianship of Kowalski on December of 1991, which is their couples anniversary date. The Court declared the women a family of affinity which ought to be accorded respect. Remember that folks a family of affinity which ought to be accorded respect. At the time of this interview. Kowalski was spending time at Thompson's home in Clearwater, Minnesota, however, Kowalski usually resides at Travilah, a long term rehabilitation facility for people with brain injuries. The women hoped to move Kowalski to Thompson's home after arranging for very costly therapeutic equipment and

services. published in the magazine summer issue, the interview includes comments from Kowalski who has severe speech and locomotive and memory problems. And she participated by using and digitally voice speller system and an interpreter and some other things. It has very emotional episodes in it and kind of an embarrassing one too. They were talking about Kowalski state of mine and Thompson was saying that Sharon wasn't cooperating with a nice straight speech therapists work agenda. she typed out that she'd like to make love to me instead. And the therapists turn red but recovered and said, I guess that does sound much more exciting than any of the options that I gave. Thompson said her partner's openness about sexuality allowed her psychologists and therapists to testify in the couple's favor in their last court battle, and she said she'll need a lot of help to accommodate Sharon's needs. Our dream would be to get Sharon home sometime soon when is slowing us down is the fact that we are so far in debt from legal fees and she can't care for Sharon all by herself. Even with 12 to 14 hours of attendant care a day we may qualify that which we may qualify for and have to cover 10 to 12 hours both day and night Sharon needs to be turned given to feedings and those kinds of things. To raise money it will take Thompson has been giving talks nationwide as well as continuing her college teaching schedule. She said that she and Kowalski are planning to redefine what family is and find a structure that will work for us. The one thing that's remained very clear through it all is that Sharon still loves me and I will always love Sharon. She said I want Sharon home with me as long as that's where she wants to be. And apparently that is where Kowalski wants to be. In the interview she affirmed that she felt the same types of things for Thomson that she felt before the accident. When asked how she sees the future of the relationship Kowalski typed in L O V. The legal fees to bring costs the home was totaled more than \$220,000. While therapeutic and disability equipment costs another 41,000 contributions to help cover these costs may be directed to pens and pencils out boys and girls. The Institute began classes last week as students gathered in borrowed rooms scattered around West Hollywood to explore topics tailored to homosexual audience by homosexual teachers. This is a way of validating that I exist. I've been denied that in other courses student Jean Hmong Berg, Mom burger at West Hollywood said at the conclusion of his first three hour session devoted to psychological development of gays. Other offerings included courses and titled queer space gay Isn't lesbians in their built environment, and an examination of how homosexuals relate to the city and lesbian writers of the 20th century. The idea of the institute was developed a year ago after Christopher Petrucci, a city planner met Simon LaVey and neuroscientists known for his research showing anatomical differences between the brains of homosexual and heterosexual men. The finding suggests a biological link to homosexuality Lavey 49 wound up taking leave of absence from the Salk Institute in Mahalo and moving to West Hollywood to help work on a forthcoming book and help Patricia establish the school. Free space was found teachers were hired and five 8000 course catalogs were given away. LaVey originally predicted the institute would have 50 instructors, and 500 students in the first year. But so far, only 75 students have signed up and 14 of 22 classes listed in the fall catalog were cancelled. The VA acknowledges that a roster of nearly 24 courses for the institute's to debut was too ambitious, the \$175 a course registration fee, may also have deterred some potential students.
