As you probably already know, Since you are an intelligent audience, and since you've been listening to us for all this time, you know that there are different kinds of transgender people. There are cross dressers there are transsexuals, there are drag queens, there are all sorts of different categories that transgenders fall under. And I want to start out by talking about married cross dressers. Okay? Okay. And I will say to them, I did you tell her you were married at the time? You you tell you're a crossdresser? At the time you got married? No. Did you tell her you were a crossdresser? After four or five years of marriage? No. Did you tell her before you had kids? No. Did you tell her after you had the kids? Well, yeah, kind of when she caught me wearing her clothes? Well, you're in for a really nasty divorce. And you set yourself up for it.

So she is now a transsexual is legally a female is post post surgery. And by all to all standards, all of that to the outside world. They look like a lesbian. Couple. Absolutely. Okay, now that's that that's the best of all possible situations is when a when a transsexual or is able to sit down with their spouse, and they are able to work it out. And for the good of the children or for whatever reason choose to stay. I will tell you, honestly, Beth, and Teresa, two of the best parents I've ever met. And I'm not just saying that because they're friends. It's because they really are great parents. Teresa spent all kinds of time with the kids in various activities. Beth did the same as us. She used to drive me crazy because I say we're best let's go do something this weekend. I can't go camping. We're going to the Girl Scouts this week. And we're going to the Boy Scouts next week and we're in shoes, just great parents. Okay, so there are a lot of people out there I'm sure who say well, how can you possibly be transsexual and be be married? Well, Beth and Teresa one example that. Okay, let me take the example of Lori's case, not Lori and I have been together going on almost going on 14 years. But we are not legally married. And fraught and probably never will be. The reason here's where it gets real tricky. I am, I am a transsexual, but in the state of Texas. They have this weird thing where they say if you still have your genitals, you're male. Okay, so technically, I probably could get married to what DeLorean? If I chose to technically you could I could get down to San Antonio in bear County. I could declare myself as being a male. I can get married to Lori and we would legally be husband and wife. Okay. Now I don't mean to confuse the audience here. Because I hear I can see eyes glazing over what that you said you people were transsexual? That's right. I am. But Texas has a very odd thing, thanks to the Christie Littleton case. Right. And the story there is Christy Littleton is it's a long story but the bottom line is the state of Texas said if you have male, if you have male chromosome male chromosomes, then you're a male whether you have surgery or not, right, a truly stupid ruling. It is but the result of that was you could get legal same sex favorite gym, in San Antonio, all you had to do was just show that your birth certificate and show that. Okay? Now that's that's very that's great a few people took

advantage of that and they're still taking advantage, I'm still getting emails about that all of that is fun and well and good. We do not have any children, I do have a child, a child from a previous marriage. But I was hesitant called say she has child because she's in her mid 20s. And we have not spoken to each other for five or six years now. She has chosen to leave my life and that's fine. That's her right to do that. The point though, is that you can that to be trained to be a transsexual means that you have options perhaps that gays and lesbians might not have. Here's where it starts to get tricky. Let's say that one of the partners dies. Okay, let's say in our in our, for example, in my relationship with Lori, let's say that I passed away, Lori does not get any my Social Security benefits. Because because we're not legally married. If I had life insurance, it's possible that that would be disputed. That happens all the time. If I owned a property, that would be disputed. Now I can go in fact, Lori and I have done this. We went to an attorney. And we had legal documentation of made up so that we have I have a medical power of attorney for her of legal power or attorney for her. I have access to her account our accounts if she becomes ill, and we need somebody to be able to do that. And of course, she has mine. So in effect, we would be we became a legal couple, because we went to an attorney to have this done. And I would strongly say this to anybody that whether you're gay or lesbian, or if you're transgender, if you haven't done that paperwork, you're nuts. You're nuts. How many stories have you and I heard over the years, Jimmy, of people who went to the hospital to their lover who was dying, and they wouldn't let him in? Exactly. Because he had no legal standing. Right?

So we went round and round and actually I was married for several months before we found I only got a notice from the Pentagon that they had decided to simply drop the matter. Wow. Wow. Now of course, this was the Vietnam era. And yes, there's this there was used to joke about in Vietnam during the war, about this guy who is into the military doctors office, Doctor says Sit down, he does and doctor says you're in. He says, Wait a minute, you didn't check my heart or my lungs or anything. The doctor said, listen, stupid, you saw the chair, you heard I said, You did it you're in. And it was pretty much like that, it was pretty much like, I actually had packed two suitcases. And both of them for it were for in case
