So if you got an attorney, if you've got no one chances are you're getting through to an attorney on a collect call from jail. This is going to be a collect call, or relatively slim call collect the person who's going to accept the dollar and 35 cents call Who is most likely to have the time and the energy to look after your interest by making several calls. That's interesting. I wouldn't do don't necessarily Call your attorney because your attorney could be in court your turn it could be somewhere in zero downtime and exactly how they're not there. And that may have been the first chance you might get another chance to telephone for a couple of three hours although you will be given in Houston city jail they rather generous with the telephones actually be what you get be given continuing running opportunities, but call the person that has


the most time to devote to your interests and let them put together on the telephone and and understand that before you panic and start throwing large gobs of money at bail bondsman and I refer people to bail bondsman every day. I'm not anti bail bond, but understand that in Harris County, we have pretrial services. And if you have a job and a telephone number, and an address, you qualify and no checkered history of having escaped. You qualify for pretrial services release at no cost to you. Now what is that? I don't know what that is released. Basically in your own recognizance goes most important thing after you get arrested is set a court date and show up in court.

Under the Basic deal, my bond was 2000. I could put up \$2,000 That they would hold for me and return to me if I made every court date until the case was finally disposed up. The first time I missed a court date, even by 10 minutes. 2000 has gone. So you had to be able to raise 2000 No, no, no, no, no, no, I had to be able to raise two to 300. If you went to commercial bonds, but then I then I'd go to a commercial bondsman, he would promise to pay the forfeiture if I didn't show

up. And if you didn't show up, he would also hunt you down and drag you to jail. Right. Okay.

Pretrial Services. Most people who have native bonds, the importance of the bond is a guarantee that you will show up in court. Most people who get into relatively minor problems, like D are going to want to go up to court and clear their name. Right. And so Harris County, pretrial services, has a county agency that looks at your veil, right, you've lived here for x number of years, your family here, you rent an apartment here, you have furniture there you have a telephone, you have a place of employment, you can be reached virtually 24 hours a day, this person has no risk of not showing up. So we're going to let this person out basically on their own recognizance. And I'd requires the signature of the judge in the court where the case is being heard. But that's usually a routine matter in most cases. So before you go Squandering a lot of money, trying to get out of jail, considered that pretrial services will probably get you out within 20 minutes to an hour of when a commercial bondsman would get you out.

So it was definitely expedited treatment. They didn't get the paperwork for another couple hours. But everybody knew at that point that a release Bond was coming through. So they didn't transport me down to Central they didn't transport me to county and you

Because the United States Supreme Court and buys the city of Houston when Herman short was the crypto fascist bleach if we remember, you cannot kill people for their inability to pay traffic fines. Now, refusing to pay traffic fines is another matter, right? But the inability to pay traffic fines. So if you are indeed indigent, and you have an outstanding ticket and you're not going down to court because of the money situation, go on down, stand in front of that court and say I cannot afford to pay I do not have the money to pay this ticket. And they must give you time to pay it. And what they will do is they will say well, can you give us something and then maybe 20 bucks, I'll take 20 bucks on a \$400 ticket that ain't too bad. And then they will set you in six months to come back and they'll try to get another 20 bucks at they They will threaten to put you on community service and have you out picking up trash in the park. If you want to work it out that you work that out \$200 a day. But they cannot lock you up. Because you cannot afford to pay a ticket. And the case that says that is taped versus share, what does it mean that you can't afford to pay a ticket? Don't have a job? No, no, no, you're not expected to pay tickets with money that you need to pay utilities buy medicine and pay rent. Okay. And the courts very clear about that. We're not ambivalent about that at all. You've got to you know, if if paying a ticket means that you're going to get evicted from your apartment and have to live under a bridge for that month, then the courts have said no, you have you're entitled to priority. Now, when you get down there, Sylvia Garcia, who is now expecting our support for county attorney will try to con you every way that she can, because it's just the way city judges are into getting some money out of you and getting you off the roads. Main thing they want to do is get you off the dock. Sure. I can I can. I don't want to carry you from six months to six months, right. But I've literally known people that have gone down there every six months and given them 25 or 30 bucks, they've been awfully uncomfortable. And
