Well tick tock, tick tock, it's 1973 And Texas criminal statute is more cobbled up than anybody else. It's time for a new statute. So some young men in the Texas Legislature, State Representative. Would you believe Mickey Leland? State Representative Would you believe Craig Washington with a great big afro as a State Senator, would you believe Barbara Jordan? Yeah, all got together on the various adheres jurisprudence committees, and they adopted the Illinois Penal Code. Cool. Governor Brisco refused as I called one now that didn't know about them. And he he gave clemency to everyone locked up in Texas prison under the old sodomy statute, which was a felonies decades. Now. You'll notice there were no heterosexuals in Texas prisons. For oral sex, Texas had an illegal anomaly. It's a footnote in Black's Law Dictionary. Only in Texas is their old sodomy. That does not occur in anybody else's law. But oral intercourse, which was illegal under Section 2106. And illegal under the sodomy statute, and annual intercourse, which is, of course, the classic definition of sodomy. And all those those were felony offenses for is going to be punishable for for prison time. Yes, from time five to 15 years. And if you got convicted three times under the sodomy statute, then the Texas habitual criminal act kicked in. And you could be sentenced to life in prison for doing what all of us do when we do what we do when we do it. And so, all of a sudden, that becomes a Class C misdemeanor, where the officer really can't even arrest you. I mean, it's a citation event. There's no jail time, supposed to come in catch you're doing it. So Aha, and write you a ticket and they show up in court and leave presumably so you can go back to doing it

But the point that I want to make is that young Mitchell is like a real lawyer who can handle it. And young Mitchell who works for the law legal firm that has been briefing my federal cases, from the very beginnings is bernburg and Williams. And I mean, I'm real proud of it. At the very beginning of all this. Young Mitchell and his representative met with the Harris County District Attorney's Office, and it was agreed by all parties, that this issue was going to appealed until the final resolution of 2106. Yeah, I don't care what you read in the paper about Johnny home finding something to gum his microphone over. But whatever that is, I understand that Johnny is in favor of the repeal of 2106. Why would Johnny humse be in favor to the bill 2106. In the years since 1973, there have been five cases of 2106 in the jurisdiction of Harris County, coming from a civilian situation. We don't know what people have been charged with in jail and in prison, but in the free world situation. There have been a total of five application to 2106. The last two are the subject of this case. So there really only been three incidents, three people charge and two other incidents besides this one In over 25 years, 25 years, therefore, it does not pay Johnnie Holmes to train his prosecutors to prosecute 21 Ah, it is easier for him. So

when you hear the word appeal that takes Court of Criminal Appeals, that is not something that is a surprise, all parties agreed going in here that we were going to do this, because we have been here before it was the England case in Dallas, a woman by the name of England lesbian, wanted to be a Dallas cop, and they wouldn't let her and she sued. And she got to the Dallas District Court of Appeals. And the court ruled that 2106 was unconstitutional and unenforceable by all reasons and purposes. And the Dallas da did not take it up. Therefore, that was a dead end run. That did not get rid of the law, presumably 2106, what became unenforceable in the Dallas District Court of Appeals counties. But it was a great going in, that this was going to appeal and get rid of it. The principle is now we've tried several attempts, yes, to get 2106. There have been two cases there was the Baker case, which was a federal case went up. Judge buchmeier in Dallas gave us a very fine opinion. And that was appealed to the Fifth Circuit Court of Appeals. And then that was appealed to the Supreme Court United States. And A Funny Thing Happened on the Way to the Supreme Court, the Hardwick case come in laterally out of Georgia, which was a felony statute, and it got all the press and all the attention. So Baker became a footnote to Hardwick. And when they pouted Hardwick out, well, they didn't really board I was five to forward. And Justice Powell said, three weeks after the decision, if he had known his favorite nephew, and all of his clerks were gay, he would have voted the other way. It's true.

A young man was driving down there near Santa Fe. And he had one of those rainbow bumper stickers, right? Like bumper stickers, and a carload of Christians with little fishes on the back of their car, chased him hollering faggot, queer, faggot, queered throwing bottles at him. And he turned up on the

freeway and there was a highway patrolman. So he walked up next to her, and she got out and her uniform and gotten trumped. All of the sure all of the prayer in schools, bumper stickers, and they run away but that license numbers being traced

The assailants live in the house with a relative who is a deputy sheriff that patrols the area. Whoa. So we've got some problems with getting a case filed. So I begin to notify me, Mother hill gets these calls. And if you know of a call out there, the radio land if you know of a call of anti gay violence, I should know about it. Because what I did is I gave first the sheriff's department a call using my Lois Lane pass. I mean, this is a regular KPFT radio working story and yada yada yada, then also notified other media and so I've notified some other media, both local media and national media, and we're gonna descend on montgomery county, so that if there is a lack of interest in prosecuting in the Sheriff Department, because the assailants are related to the sheriff, we should be able to plumb the bottom of that report early next week. You are absolutely going to be hunted down those 10 Guys in Woodland, most of which are friends of mine now, incidentally, that they're in prison. Yes. But

they thought they got away with it because it was anonymous. I use the media until I tracked him down like a bloodhound. You are not going to come into my community, and jeopardize the lives and the safety of this community. And you know what, I would do the same in the interest of your protection, because that's the way gay people are the non special about radio. No human being needs to be in jeopardy for who and what they are. I don't care what their political beliefs are. I don't care what their religious beliefs are. I don't care what sexual orientation they are. Nobody is not to gay people. Just a brief word. All right, put a camera in your car, even if you go down to the local drugstore. And you buy one of those little boxes with the film in it that you throw away, put a camera in your car with a flash ball. All right, because that is the weapon of choice for you to carry in the interest of your safety. So many times, I have been in situations where I needed to protect myself or other people. And I camera is the safest, best way to do it. Take a picture. It'll record the license number. You don't have to remember it snap. Take a picture. You'll know what they look like. You'll have a picture to go into court because they will get caught mother is going to track them down. Oh yeah. Until they're caught. All right. Don't think that just because it's a transgendered person standing alone on a street corner on Houston, that nobody cares. I got up this morning. And I cared and I have cared all day. Don't it doesn't make any difference if it's somebody with a little rainbow flag out in the suburbs. I care and you're not going to get away with it. Gay people be aware of where you are transgendered people bisexual lesbian. I mean, women know because of the dangers of violence against women. Do women stuff guys? All right. I mean, look around, keep your eyes open. Walk on the light side of the road.
