So that was me. One person told me God was doing this as a test of my worthiness for eternal life, which is not a Christian concept, rather interesting sort of words. Yes. I never said no, it's the devil, the devil is doing it to your being plagued by demons. Another person said it was my mother, because he was too strong of figures that it didn't separate from. Another person said it was my father, because I didn't identify with him. And then another person said, and this is what most people probably hear it was tested in the last year somewhere back in my past. So you know, I had it was, it was me, it was God, it was to dabble with my mother, it was my father. It was test her. And you know, this all started and none of these people knew what the heck you were talking about. And it sounds like to me, the person, the the five blind men and the elephant and they come on, say, you know, I think an elephant is like a rope, or a tree or a wall or like a leaf during different parts of the body. But it's an elephant. It's not each one of these things. They didn't know what they were talking about.

I did not receive the unlisted phone number to my children's residence until four months after the decree when I finally browbeat my dad attorney and filing for contempt that to me that to be an automatic because the first thing that my ex did was went and unsealed all of the court records in the St. Louis Post Dispatch. And the court didn't do anything about that. It's just the vendor field to protect the children's privacy. And he went and just slapped everything gave psychiatric evaluations, you know, court testimony, court documents, and the court did nothing. They have been thoroughly intimidated by far right extremists in that county.

You may recall she said that she has counted 40 with his audience, right when placing organizations within a 10 mile radius of where he lives. But all of those, the one that was the greatest threat, she thought was focused on the family. And he spent some time talking about how well how well funded they are coming to radio stations. They're on the amount of power and clout they have, and most importantly, how much money they should raise. Now having said that, let's relate all of that as to what we're going to hear next. Okay, so hear it now what now? Are we filed for the field as soon as you XYZ? Yes,

well, we both kind of did, that there was one provision that did not make a lot of sense, in the decree from my standpoint, and that when I had temporary custody of the children, it was stipulated that I could not cohabit with another transsexual, nor sleep with another woman, which is ridiculous, because owing to the fact that state of Florida will not change my birth certificate, the only person I can legally marry is a female, and have the court on essence is telling you that I can't sleep with my legal spouse when I have temporary custody of these kids. So we appealed on that fact. And of course, they didn't want me to have any contact at all. So

they not only appeal, but they'd have to get the court orders vacated status, modified, depose what's called a bond is super tedious with the appellate court which is attempting to stay the provision. The court in 100% of these things, denied their motions. But nonetheless, I still have not talked the first time to my guests. And it's largely because of the organization organizing abilities of the fundamental experiencing calls and the intervention of the Lawrence spent funds really violated a lot of their charter. I have really studied these people. I used to be an intelligence analyst and I'd analyze the heck out of these people. And they normally work through pro bono attorneys. And then they pay somebody incidental court costs like depositions and experts and things like that. Now, in this case, they have deviated from that because they're actually paying for a attorney who's not one of them, not a Christian, they happen to get one of the nastiest divorce attorneys in the St. Louis area, who commands an hourly rate of well over \$250 an hour when I've heard, and just at the primary court level, they have spent over \$1,000 On this case, I imagine, given this high court fees and the fact that three attorneys and everything, I'm sure they spent 10s of 1000s of their contributors money, because they were really stunned by the fact that they've lost at that trial court level. Okay, so now they're losing trial court level, and they file an appeal, ended up with a with a judge who the who's essentially sympathetic to them. And that runs over the three judge panel, one of the judges was sympathetic to me, Well, I'm gonna say was sympathetic to the law. Because the law was done in that decree, it was a case of first impression, but nowhere in Missouri law and I've researched the heck out of that to this and say that just because you're transsexual parents, mean, you can't see your kids again, it never it doesn't say that it says In fact, this public stated policy of the state of Missouri is to ensure frequent and meaningful contact with both parents. And there's no ifs, ands, or buts about that. Now, it does talk about restrictions on visitation. But in the case law that has only been interpreted for parents who have tried to kidnap their kids and take them to a different jurisdictions who were convicted of domestic violence, sexual abuse, or were drug or alcohol abusers. So now they have opened up a new category, all you have to do is be clear. And the other side, if they claim that you are an endangering this to your kids, you don't have to specify too much with that name, then the judge can delay your contact with your kids for at least a year. And then you have to prove that you have somehow been rehabilitated or no longer a threat to your kids, before you can have any contact with them. It's just an outrageous travesty of their law.

And I really don't have anything a meaningful phone number to the residence, because that's an answering machine probably stuffed in a drawer with the ringer off. And I never get my calls returned. And it's been four years since I've talked to my kids, for years, oh, my God. And today, the other side has decided to tell them from their own little perverted slant, what's been going on with me. And even shown pictures, my oldest son is on Prozac. He's all 10 years old is on Prozac for the second time in four years. Effects demonstrable directly related to this case, the first time

was because Nick, and I didn't find out until after his back. So they drugged him out with Prozac. And I don't want to talk bad about Prozac, except in this case, they were basically using it to drug him. So that wouldn't try. I couldn't have contact with them. I mean, the easiest thing would be put the boy on the phone and let him talk to his dad. But he didn't want to do that they would rather conduct some experimental therapy, which has not been okay by X ray. And he was on it for a year then. And he's on it again. Now, because the custodial parents Dennett was engaged to somebody not spending enough time with him as it was related to me. So anyway, I don't even have any mobile phone number to their house anymore. I still yet to have that first phone contact. And my phone calls not being turned down. I'm not sure my letters are getting through. I lost joint legal custody, which is a travesty. They said, well, there wasn't any evidence that these two people having worked together, which I could have given him about seven areas where we had things like on their medical care, their religious upbringing, we record their summer activities we had coordinated and worked fine, as long as Janet scales thought that she was going to be accountable to a court of law at the moment where she decided she wasn't he just slammed down with her. Did she please stop returning phone calls or stop writing? They were remaining the issue of visitation that this is a tragedy because it's going to be a delay. And it's probably going to cost 10s of 1000s of dollars for both parties. Because you're talking guardians, guardian ad litem, and for the children being appointed. You're talking about More psychiatric evaluations of all parties more in court costs, more depositions. This is a tragedy.

In many of the cases, the transgendered people are winning. But where they lose, they seem to lose. Really big if they used to be in an either or situation. Either you able to win all just about everything if you want, or the courts come down with rulings that are so impossibly horrible. You have to wonder, what confused education did you ever have to do something stupid?

I don't believe it's a question of education. I believe it's a question of politics. In the case of my case, and I believe, I don't know these other cases, but having reviewed a number of counts, and and even in Missouri, I have some contacts there, they've gotten very favorable out of court settlements, given them substantially, I think it all comes down to the custodial parents. If they happen to be a religious pigheaded fanatic, like my act and have to be connected and happened to be connected with the evil fundamentalist, then it's likely that this will be turned into a crusade issue. In my case, the judge issues that decree that was favorable to me, they took revenge on him. And he was elected in the next election, he lost his \$91,000 a year job. And now in St. Charles County, I have significant evidence because there is an actual conspiracy of the elected judges there to never hear this case. My attorney has talked to these judges, they meet on a monthly basis, they have discussed my case, and none of them want to touch it. So I'm unlikely to ever be able to recover court costs or even talk to my kids, probably, because they don't have the moral integrity to hear this case, which is actually a vote in favor that I've been screwed with. Because if they could spank me legally, they know they'd be heroes of the community. And they would have no trouble doing that. But they know that dance

chaos has gotten away with breaking the law bragging about it, the papers, and they don't have the moral integrity, to hold her accountable because they are afraid they'll be unelected like Bill Alomar was

And we're attempting to steer it before an unelected judge in a neighboring county that will, you know, not be held hostage to the far right religious ties. And you know, maybe we'll have a chance of they'll really see that, you know, the children's best interest is to have some kind of contact with me. And I'm the kind of person you know, today's Tuesday, you're trying to ram this down their throats to impose my immoral lifestyle, whatever that means. On my children, you know, all I'm asking is to have contact with them. And I think that there's nothing that I can't do other than take them into the ministry. And quite frankly, that I did before I listened to the testimony of one of the counselors that evaluate like, my kids, it's like, what did you like to do with your dad? Well, I like to go into the woods and we go after frogs and things like that, hey, I can do that. Now. You know, that doesn't wreck my femininity or who I am now. And I'm a very attractive person. No, people are not going to point at me as we go down the street. These kids are not going to be embarrassed. It's just the religious right knows that if they can't win against an Air Force patting graduate who has a master's in business administration, who the smart moral person, they know that they can't win against them, they can't win against anybody. And so that's why they're pushing this full tilt.

It works in that focus on the family does have an annual attorneys conference where they talk about, you know, the same sex marriage issues and the head of the Alliance Defense Fund as a keynote address, and he wanted the two sponsors start with Christian legal society, which is one of Pat Robertson's legal organizations. The bad thing is this June, this next month, during Father's Day, how about that they're starting what they call a National Litigation Academy. And they're about purpose of this academy is not to go after the right of children to pray in schools or things like that. But to have an impact in these so called Family definition cases, they're going to train about 200 attorneys per year. They they want to be able to go in and essentially take queer people's kids away from them. That's it this on the basis that they queerness regardless of whether or not they're qualified parents. I mean, the other parents could be the narcotic abusing child molester, but that's okay. You know, that case in Florida, where the axe murderer got custody preferential to a lesbian mother? Yes, this is kind of what they're going after 200 attorneys per year, that's their aim, they're going to train people. And I just want to say to all the Gay, Lesbian and buying listeners out there, don't think they're not coming after you. I, unfortunately, have got a very loud and rousing snore from all of the gay legal groups with the exception of the lesbian. What's their name out there in California? And that's probably because the one person that I've been dealing with out there is also transgendered. Yes, yeah. NCLR that's the only group everyone else has basically treated me as if I'm not queer enough. And it's galling for me to read, and the Washington blade about how the ACLU gay and lesbian rights project, how lamda is intervening or some of these other cases, and I'm sorry, but they're

not just as they're not as egregious as this one is. I haven't even talked to my kids. I got the law on my side. My point is, religions, right is gearing up to wage a war against us. And I think we all should take this seriously. And we should all come together. And don't let them go after just a transparent because you think that's not going to affect you. Because in my case, the case law is, I don't care what your orientation is, if they can claim and somehow pleased, where there's an elected judge, that you're an endangerment to your kids, you can kiss off seeing them again, you can kiss off seeing them again, the burden is gonna be on you. And guess how far you're gonna get with that and seeing your kids are not just talking custody. I'm talking visitation I'm talking, being able to talk to them all the time.
