The Reverend Julian rush a self avowed homosexual has been reappointed as associate pastor of Denver's St. Paul's United Methodist Church. The announcement was made earlier this week by Roy Santo Santos refuses to discuss the decision. He's a bishop. Church rules call for reappointment every two years of any minister who is in good shape. Rush age 48 is one of the only openly gay practicing Methodist minister in the USA. He was the center of the 1984 national church debate resulting in a referendum barring homosexuals from orientation and appointment to the Church's position. Rush who is divorced has been at St. Paul since 1981. His congregation of about 100 is predominantly gay. Last week to Denver Methodist ministers filed a grievance against rush, which could prompt further church review of his qualifications. He's also director of the Colorado AIDS Project, Rush said he is not seeking controversy, but vows to fight for being ousted. The work we are doing here is an important valid ministry. He says somebody's got to do it. Also this week, about the H POA case. The police charged Sergeant a Police Chief Lee Brown has recommended that daily was the one that has admitted shooting the H POA offices that he'd be fired. I, I won't tell you where the source is. If you go to Record Rack, you will probably be able to find a copy of that or they'll be able to tell you where you can find it. It's not, you know, we don't necessarily like every once in awhile, play some songs that are a little bit controversial. Just like sometimes I subjects a little bit controversial, just like this interview is going to be a little bit controversial. Today well, first of all, I better tell you this is KPFT Pacifica Houston, a community sponsored radio station, you're listening to the Wilde 'N' Stein show. My name is Jack Lewinsky and with me tonight, or as the evening is rolling on here, Nick Adams, who is chair of the board of the Montrose clinic. And tonight we're going to be talking about the HTLV three test, which is basically simply known as sort of the AIDS test. Okay. There's a lot of controversy over this test. Basically, most people community have been very much for the test for blood screening. We had first of all, through Mr. Teague talked about asking our people or anybody who was an active person in the gay community X sexually active not to give blood. And in fact, before this came about, I used to give blood on a regular basis, almost to the day of the eight week period. And once I was asked not to give blood I stopped giving completely due to just that they felt that it would be better so that there would be no problems in the blood supply and the blood supply remains relatively very safe. In fact, the chances of getting AIDS through the blood supply are all I believe one in 2 million, if I'm not mistaken, are a slight, very slight. And it was my understanding is it was felt that some people might even though asking people not to do it

might go take in donate blood, just so that they can find I'll be three tests. So my understanding is that what that is why the clinic got involved in giving this test as an alternate site.

That's one of the primary reasons the clinic had been discussing this at its board meetings for the past several months. In these deliberations in the board, we immediately identified three major areas of concern. One, regardless of clinic actions, one or more alternate test sites would be established. The blood banks are currently being inundated with requests for the tests, and the ability of independent labs to purchase the test directly from manufacturers must be considered. Second, as well as the community. The clinic itself was deeply concerned with patient confidentiality assured by not keeping lists or other patient information associated with test results. Okay,

First of all, we're not recording patient name. Okay, we are using a separate code number that is not tied in, either with the patient's previous clinic record if they had been a previous patient, or in the clinic numbering system at all. Okay, separate unique number. Basically, it's the patient's date of birth. And the visit they had for HTLV three whether they were the first person that came in the second or the third, okay, as the only information that's transmitted to the Health Department. It's the only information we get back with test results,

we not only will not have a list of names, we also will not have any test results. Okay. The test results are returned from the city lab. We do not maintain any record of his being there other than we had so many patients in coming into take the chance there were so many positives, so many negatives.

one of the reasons we had was the concern for the the member the clinic, volunteer staff and the board itself are memoji are not members of the gay community, we have a very broad spectrum of individuals who volunteer their time and services at the clinic. All of us, however, share these common concerns. The HTLV three antibody test is not a test for AIDS. The intention of the test when it was developed was merely to protect the nation's blood supply. That is all it was designed to do. It's being used for blood collection centers and is also being used in approved AIDS research projects of one type or another throughout the country. At this present time, there has been nothing coming out in the literate medical literature to indicate that has any diagnostic value in predicting whether or not an individual currently has the AIDS virus if his test is positive, or if he will, in fact, come down with AIDS at some point in time if his test is positive.

The city health department had been notified by the Texas Department of Health that grant monies had been received by the state to set up alternate test sites in various parts of the state for HTLV three testing. In this memorandum to the city, the State Department of Health had suggested that they contact the Montrose clinic as an alternate test site. On might have this came as a surprise to the clinic we had been in have had fairly close relations with the

State Department of Health, but we're not aware that something of this magnitude will be coming down the line. We've had many negotiate negotiating sessions with Dr. Hodgins office. Several of our concerns were voiced immediately. There were several that took some time to resolve the position of the clinic was that we would not participate as an alternate test site unless we could be assured of patient confidentiality. OD and second that the proper pretest and post test counseling would occur.

test a one on one face to face. The individual is called in on his appointment staff coming over and assisting the clinic inpatient counseling will first go over what the test does or does not do. Second, we'll explain that it is just a test for the antibody, it is not a test for AIDS, it is not a test for the AIDS virus. All it does is test whether or not you as an individual have been exposed to the AIDS virus and have produced antibodies to that. It is not really a diagnostic test, you can't use it as a as a valid predictor of someone's current health status or future health status. Because of the numbers of false positives and false negatives, there may also be a question as to whether or not the test result coming back is a true and accurate picture. If the individual is for whatever reason, is then insistent upon having the test done, yes, we will go ahead, draw the blood sample, send it to the city lab for processing, and ask the individual to return in one week. The turnaround time is generally 48 hours to run the test itself. But in the event that there was a positive test, they would then have to spend another two days or so to rerun the test to make sure that the first result was not a marginal or a false positive. Okay, when the patient is comes back for his return visit, regardless of whether the patient's test results are positive or negative, he will still have a counseling, even if it's negative, that's correct. One to indicate that probably is a negative. But that does not mean he has not been exposed to the AIDS virus in the recent past, it could indicate that he was negative at that stage, he took the test, he may have been exposed to the AIDS virus recently, and his body has not made the antibodies, which would then show up on this test. It could also be a false negative, it could still be a false positive. And if the test is positive, the patient would then be counseled as far as what a positive test means, at this point. What does it mean? It means basically, that his body has been in contact with the AIDS virus and has built up antibodies to it, it virtually means no more than that. We can't say well, you're going to be coming down with AIDS or pre aids syndrome within the next few months. It doesn't mean that at all. We can't say that he's been exposed to the AIDS virus, his body built up antibodies, and he's fought it off. We can't say that.

Basically, you keep coming back to the idea that this test was just set up to test the blood. That's correct. But it is an alternative site that persons can if they really feel they need the knowledge of having the test taken, they can come to the

Now one of the interesting things we've just started this test as of yesterday, we're doing scheduling appointments once a week. There are a number of individuals who had called for the test inquiring about it, who themselves were not a part of the gay community. They were parts of the other high risk groups identified. We've had female sexual partners of IV drug abusers. For example, or so as they have indicated, the individuals coming in are not those from what I understand who would normally be seeing or coming in contact with the gay press and the information that's been coming out from the Kshs foundation from the clinic from other organizations regarding the validity of the test and what it does and does not do. There are a lot of people calling in who are what are considered in the worried well category. Their lovers may have had AIDS or may have AIDS, and they are concerned about their current health status.

during the initial grant period that we're working with with the city on this, which will go through the end of July? There is no cost to the individual. Okay. Now Whether or not the clinic will decide to continue offering the test after the end of this grant period, that will again will have to be decided by our clinic board and also working out details with the City Health Department. The purpose of the grant period was to fund the initial startup costs. By my dad, the clinic is receiving no direct funds from this the only support we are getting through this grant is the supply of needles, the syringes, the test tubes for blood collection, the time of some of the city personnel for counseling, and the costs that the city incurs in administering the test itself and doing the testing process. Okay, so this is not a money making business, not a money making venture. We have been discussing the details of administering the test with Dr. Hans office, we have not discussed finances. We don't expect to receive any finances. If someone else they would like to give some to the clinic as they would to KPFT, we're more than be willing to accept it. We have not asked for direct funding for this from the city through the grant project or for any other time. The city during this time is also trying to determine what its costs are for running the laboratory tests. I really can't even come up with a ballpark figure right now of how much it costs to do an HTLV three test, or for the counseling.

We've changed the name to gay sports day to include the various sports organizations, which also includes women includes women, yes, also. To start off the day, we have a tennis tournament with the Houston tennis club and the Oak Lawn Tennis Association. They are going to have their fifth annual Texas Cup Tennis challenge. They switch off year, every other year in the different cities this year happens to be Houston. So we coordinated to land on June 22, for gay Sports Day. The second event we have planned for that day is the Sunbelt singles Championship, which is the first of its kind. We are bringing the five best bowlers of all the gay leagues in Texas and New Orleans. I mean in Louisiana, great to compete for the best of the Southwest as we're coining it. Where is that going to be at it's going to be at postal plains on South post oak. And that will start at 11 o'clock. And that has been sponsored by Montrose Sports Association at no cost to any of the players wonderful choices. We inviting them to participate in our in our gay sports day there. The next event that we have planned is the front runners are going to have their third annual bar to bar Fun Run. There'll be starting at The Guardian at noon, and they're going to make it to all the bars they did in the past year. So I think it's proven to be a fun time for the runners and the bar is getting involved in the general public gets to see some of the athletes all right, the athletes are coming to them instead of them having to go to the different functions. Exactly. The formation of Montrose Sports Association has an interesting story to it. We went to a conference, some members of the geek Political Caucus, went to a conference in San Antonio back in 1976. On the way back, the founder of the gay Political Caucus, the founder of the Texas Human Rights Foundation, the founder of the Montrose Activity Center, and the director of the National gate Task Force, and myself, were in the car. Naturally, they were talking about the gay movement. And when they turned to me and said, Well, Nick, what are you interested in? I said, Well, sports, I guess, and I said, we'll do something about it. So I said, Well, I guess I will. When I got back to Houston. I talked to a couple of friends and asked them if they were I was interested in volleyball myself. I asked them if they want to play volleyball, so they said, Sure, why not? We borrowed it from the chair, rehearse Park, on a Tuesday afternoon, set it up. And there were about four or five of us out there. We took a cooler of drinks and just started playing. People rode by on their bicycles. And of course, we talked about the parade in July on the Fourth of July, I probably won't be here but on tape. I'll have hoped to have an interview with the economic response committee and basically wrap up what they have done and the different segments of things going on. I'm gonna do a little editorial here. Might you have something you want to do first? Oh, no. Okay, I can go ahead. I am a I'm on the board of gay Political Caucus. And as I was sort of editorializing last week about some of our organizations who are very underfunded, and that includes not only gay Political Caucus, but many of the groups, whether it's the switchboard, whether it was a clinic, whether it's, you know, every every group is important, I happen to be a little bit more closer to gay Political Caucus. This weekend, we're going to be putting together a mailer to people who have been members in the past year and have not renewed and tried to ask people to renew and reasons what we're doing and why we asked to renew. Of course, we had a seat in January, but that doesn't mean we should close up shop and leave Houston. We've got a lot of things to going on here. As we were talking tonight, we've got all these people involved in the sports association. That would not be possible unless we had some type of strong political group if we had a strong have a strong switchboard here, that relays information. We have the CAS aids association here, which is a strong group that is dealing with the AIDS situation the clinic, giving the HTLV three A HTLV three test. And I'm sort of happy to say not too many people are taking it because many people have asked. Many leaders in the community have asked people not to take the test. And I'm here to Wilde 'n' Stein, Shawn also was asking not to take the test, we asked you not to give blood at the blood center. If you really feel that you want the test, take and then go to the clinic and get it taken. But basically, it's felt that the test does not say you have AIDS, we don't know what it says we just are happy that they're giving it for screening blood so that none of the blood goes through the system that may possibly have AIDS contamination in it. So this weekend, we're gonna be putting together a mailer asking people to join gay Political Caucus, whether you can volunteer hours or whether you can give money, it's very important to keep some of these organizations going political organizations and social organizations, because we are a community, we're very much a community and rolling as strong as our members. And if

you're not involved in that, you're hurting yourself and you're also hurting the community in at large. You're hurting yourself because you're depriving yourself of a lot of people who are very dedicated and, and doing things in this community. You're hurting yourself in some of their friends you can have I count being involved in GPC and I've been involved in this show, I count many friends, I count Mike is one of my friends. We don't see him a lot outside the show. But when we're here, we're very, we're very close we work together in our aims are basically the same to provide information and let people know what's going on in the community as best we can. And the only time we sort of argue or disagree at all is that sometimes we're trying to beat each other and getting some of these things on here, which is, which is a positive competition, rather than a negative competition. And of course, I've been pretty happy with some of the things we've done, but we did on the show, but we're, we're certainly not finished. We got a lot more things to do on this show. In July, hopefully, maybe you get an interview with Derek Dannenberg, who has just recently finished a session at the legislature now I guess Texans are sort of safe because the legislation is in and hopefully get George Gradius, who was constantly in here for Montrose district, see and talk a little bit about some of the things he's done in the past a year and a half. Tried to get him on hopefully, before he announces that he's going to be running again, if and so he does that, although that's probably pretty well taken for granted that he will be running. In fact, there's not any opposition against him. So we have a lot of things coming up on the show. But it's important that you people get involved. Earlier today, as I walked in, Mike told me about, we won't name the person's name. But somebody that has been by the show that has sent phones or answered phones helped us out and was a very good looking young person. Unfortunately, he took his life recently. And it's really a sad note that this person did that. There are so many things that you people can do if you feel depressed. Being gay is not a bad thing. It's what you make of it. A few years ago, I was not comfortable with myself. Moving to Houston. I've made a lot of friends. And I just made a commitment that I will be open and hopefully share my life with some people. And that has helped me tremendously. I recently have taken I work at a radio station recently have applied not actually they sought me out and I'm going to be working for another radio station here in Houston. And one of the things I did say to them nice is I'm gay. Is there any problem with that? He says no, your private life is your private life. So I wouldn't have taken that job if they said yes. Because I don't want to work anywhere where I'm not comfortable at now, maybe some of you keep people cannot make the same statement, unfortunately. But that doesn't mean that you cannot come and become involved in some of these organizations, whether it's licking envelopes, whether it's making calls, whether it's doing some volunteer for
