- Wait a minute, wait a minute, wait a minute, we're talking to Frank White who does the news on *Afterwards* at 12:15 every morning--

- [INAUDIBLE] I was driving by Telephone Road and Ice House.

- Yeah?

- Saw the police are harassing some Hispanic people.

- Yeah?

- Were they gay or were they just Hispanic?

- They were just Hispanic people.

- Yeah.
- They were demanding identification.
- The police were?
- Pardon me?
- The police were asking for ID from everybody?
- Right.
- Were they driving or were these people standing around?
- They were at the Ice House.
- Oh.
- OK.
- They had gone in and were like demanding ID from all these people.
- OK.
- Well, Ray saw this happening. He stopped. He went into the place or whatever and confronted the police, and told--
- Which he does all the time.
- He knew that, first of all, they cannot-- you do not have to have an ID on you.
- That's true.
- His court case proves that.
- That's very true, Mary.
- OK.
- You don't have to have ID, you don't have to prove to anybody who you are.
- Exactly.
- There's no law anymore--
- If they were in an Ice House--
- --that says-- no, no, wait a minute. You don't have to prove who you are to anybody. There is, if you go into a business that serves liquor--
- Yeah.
- --it's up to that establishment to prove whether or not you're of legal age.

- Oh.

- And all those things are handled by the TBTABC, Texas Alcohol and Beverage Control.

- Oh, I see.

- But as far as walking down the street or going into a restaurant or anywhere, you don't have to have any ID on you. Now, you do have to have a driver's license if you drive a car.

- Yeah.

- And driving a car is a privilege that is given to you by the state.

- Right.

- So you have to have that card to prove who you are and that you've been granted that privilege to drive. You can't just drive a car because you want to.

- Well--

- You have to get that ID card from the state.

- OK.

- The story gets better, though.

- OK, Mary. Go ahead.

- He was indeed charged with assault of a police officer.

- Uh-huh.

- [LAUGHS]

- He was charged?

- Yeah, but they charged him assaulting a police officer with his stomach.

- With his stomach. I guess he like bump-- I don't know if they charged him. I heard him in an interview earlier tonight on one of these talk radio shows.

- So is he still in jail?

- No, he's out.

- Oh.

- Oh well, I'm surprised he didn't swing in here and try to tell us about it.

- And then they charged him with spitting on them.

- Ah. So did he do it?

- He says he didn't do it.

- Oh.

- And he also said that he is not HIV positive.

- Oh, I thought he was.

- He has test results to prove--

- I thought he said he was.

- I don't know.

- Maybe he isn't. I don't know, girl.

- So anyhow that's what he said in his interview.

- You know how these queens are.

- So anyhow, Ray Hill is just stirring it up again.

- OK. Well--

- And there's some other stuff going on too. But it's just craziness.

- Well, Mary, come back and tell us next week all about it.

- That's what I'm going to do, but I--

- Get this group on.

- I'm just, you know.

- Well, you should have been down here to do the show. That's why you can't sleep.

- Right.

- Guilty.

- That's right.

- OK, we got to go. The news is coming up in a minute.

- Bye.

- BBC.

- Have a good trip--
- Take care, Frank.
- OK, bye.
- Come back next week and tell us all about it.
- I will.
- All right. Hey.
- Hey.
- Hey, Matt.
- You know what's going on? It says you have the straight poop on Ray Hill?
- Well, that guy sounds like he saw an interview with Ray Hill earlier or-- after I heard. I heard the first reports. But the police side of it is that he was interfering with a vice squad conducting normal investigations on bath houses and book stops in the area.
- Oh, wait a minute.
- That's what the radio report said.
- I thought they were at an Ice House or--

[INTERPOSING VOICES]

- Exactly. It was in a Whataburger, which I didn't understand. But they said that they were conducting operations in the area.
- See, they're at an Ice House, they're at Whataburger, and now they're at a bathhouse and a bookstore.
- No, no--
- Well, girl, it's been a long time since I looked at dirty movies at a Whataburger.

[LAUGHTER]

- It took place in a Whataburger, but they said they were conducting operations in the area.
- They were conducting Operation Desert Queen.
- I guess, but--
- God only knows.
- Yeah, but they said--
- Oh god.
- The police report was that he was verbally abusive and--
- Yeah, we know what he--

- --he was obstructing the officers. And that he's in-- and that when they were arresting him, they said that they have witnesses who saw him being abusive, verbally. But then they have police witnesses who saw him spit. They didn't say anything about civilian witnesses.

- Uh-huh.

- They say him spit on an officer.

- Well, I'm sure we'll hear all about it so you'll know.

- Yeah.

- OK, Matt, thanks for calling. You're not going to Austin?

- I'm working, band's there.

- Oh, good.

- Band's there, so--

- Well, everybody's there but us.

- Yeah, I know.

- We'll hear all about it next week.

- Somebody's got to stay and keep down the fort

- I know. Take care of them kolaches, baby.

- All right.

- Bye-bye.

- Take care, bye.

- Bye.

- Bye. Kolaches-- boy, that sounds good.

- Doesn't it? Boy, I remember that night during marathon. Boy, I was licking his kolaches for hours.

- [LAUGHS]

- Is that another [INAUDIBLE]?

- They're really good.

- So Ray Hill went to jail?

- So it seems.

- Oh, girl.

- I guess if you listen to *The Prison Show* at 3:00--
- He was at a bathhouse--
- You might hear about it.
- --on the north side of town. Or getting a Whataburger or something. I don't know. See what happens to the news.
- I know.
- There is no bath house [INAUDIBLE].
- I know. There isn't any.
- And I work at the police department. I haven't-- I've been at the-- I was at the police department all day and didn't hear anything about Ray Hill going to jail.
- How odd.
- Girl, they would have told me for sure, just to see how I would react.
- I can imagine. And I'm a little confused about this HIV status thing.
- I thought he was HIV positive.
- Well, he's telling the story, so--
- God, I don't know.
- It's not up to us.
- So he's not? Didn't he tell us he was? At one point on the show?
- That's what I got out of it, but maybe--
- Well then, maybe he's not.
- I don't know.
- I don't know either.
- I am.
- It's just like I don't know whether he was at a Whataburger or a bathhouse or a bookstore or god knows what happened.
- He should've been in Austin.
- He should have been in Austin.
- Yeah, girl.
- [INAUDIBLE] speak to me.
- Well.

- Oh, is he supposed to speak tomorrow? Who's going to do *The Prison Program*.

- Yeah.

- Not me, girl.

[LAUGHTER]

- Gee.

- Well hell. We went right down the toilet with this Ray Hill thing.

- We sure didn't.

- [LAUGHS] I'm surprised Ray didn't run in here and tell us about it.

- Yeah, I'm surprised too.

- Well, he's in jail.

[LAUGHTER]

- Girl.

- Girl, he's not in jail.

- Speak into this microphone, girl.

- I said he's in jail.

- Rainbow, get out of here. You're not even on this show.

- [LAUGHS]

- She's in here trying to get us in trouble.

- [LAUGHS]

- Ray Hill. I'm already in trouble with Ray Hill.

- Yeah, well.

- Been mad at me, well.

- Well, he may be mad at both of us now because I was the one that said he was HIV positive. And now he's saying he's not. So I don't know what this deal is there.

- I don't either.

- All I know is I am HIV positive and so I'm out of the closet about it. And I've done-- not only have I talked about it on this show, I've done an interview on *One to Three* talking about it, so--

- You did?

- Yeah. Yeah, a couple of months ago. On *One to Three*.

- With who?

- With you, as a matter of fact.

- On *One to Three*?

- Yeah, you did the engineering. Remember that? With Jane?

- A couple of months ago, that was last summer.

- Was it that long ago?

- Slap that, bitch.

[SMACKING]

[SCREAMS]

- OK, it was longer than a couple of months. [LAUGHS] Well, it just seemed like a couple of months. Anyway.

- Oh, girl. Now what are we going to do?

- Well, we've got the BBC coming up in about three minutes. What can we possibly do in three minutes?

- Call that Whataburger and ask them how that bath house is.

- [LAUGHS]

- Because I like Whataburger-- and no, I'm just kidding.

- [LAUGHS]

- Whataburger, ugh.

- So what-- we kind of sidetracked this song here that--

- Oh, girl. There's no way we're going to get back to this song.

- [LAUGHS]

- You can forget that.

- Oh.

- We've already had Ray Hill's belly attacking the Houston Police Department.

- [LAUGHS]

- Isn't that a sight to see.

- [LAUGHS]

- I didn't see any of that on the news.
- Isn't that amazing? Three calls and three different stories.
- Call Channel 13.
- I don't know.
- Call Channel 13, yeah, right.
- Why should they know anything more?
- Does Marvin know? Is Marvin, Starving Marvin over there now?
- I guess until we hear from Ray--
- We could call down it down at HPD and ask.
- Yeah?
- No, I'm not going-- I don't even want to get involved in this. We'll let Frank dig up the dirt and bring it in on the news next week.
- OK. Or if Ray doesn't go to Austin, he'll probably be here on *The Prison Show* and no doubt--
- Yeah, we'll probably find out that instead of Whataburger it was one of Matt's kolaches that Ray had--
- Ooh.
- He didn't really spit, he coughed up a sausage and it flew across the room and--
- [LAUGHS]
- It was the sausage that was bad and god only knows.
- Matt can really put some good meat in his kolaches.
- I didn't have one.
- You didn't? Mm.
- Or maybe I did, I don't remember. It was last week.
- You'd remember.
- It was last week, wasn't it?
- No. [LAUGHS]
- On Jimmy's timetable.

[LAUGHTER]

Girl, that was last week we had those kolaches. Girl, she's sick.

- Well, you know what they say--

- Matt, can you get those--

- Remember the last line from *Barbarella*?

- Matt, could you get a kolache here in the next 20 minutes? I doubt it. I'm just kidding, Matt. Forget it, don't even think about it. No, what was the last line from *Barbarella*?

- "Angels have no memory."

- Oh, please.
