So anyway, so for all of you who have seen Shrek two, I gotta admit, I watched this movie. I don't remember that scene at all. And I certainly didn't pick up on any transgendered people. I think I might have noticed. I think you might think I was in anyway, so I thought I would start by talking about that. Funny. That's really weird. Okay, let me tell you, like see what we I actually came to talk about tonight? I don't know. And has Vanessa been talking about this murder case in California was a transgendered person California. name is Quinn. Okay, well as the audience, let me fill the audience a little bit about boys. When it was a transgendered person, I believe she was a sex worker, actually. But Gwen was brutally attacked. And by three men beaten to death hit with skillets and cans of food, among other things, beaten to death and her body was taken 150 miles and buried in a shallow grave for years. Well, I've picked up some interesting information about this. But that's the point of what I want to talk to you about tonight, and we're going to go into some depth is the issue of deception. When is it deception? And what does deception mean? And of course, it never is going to justify murder. No, but from a transgendered point of view, what does that all mean? So I thought I would tell a little bit about this this case, first of all, the prosecution contended that the three defendants be in strangled her after discovering that she was biologically male. Now the issue hear is that Gwen went by the name Gwen. consider herself a female told people that she was female, acted and dressed as a female. So in her mind, she is female.

Well, they were there did here's they basically took the homosexual panic defense and said, Oh, let's make it the transgendered panic attack. It's essentially the same thing. They rather than claiming their client's innocence, the defense blamed her for the crime, had she not conceal her physical gender, the defendants would not have been thrown into a rage and therefore she would not have been killed is the argument. Now, you know, that is so convoluted, you know, follow the bouncing ball here. Okay, should the if she had not hidden her gender, they would not have gone into a rage and not killed her. As well as if,

They couldn't decide between murder one, or murder two. That's why it was a hung jury. Oh, so we're gonna have to go through this entire thing all over again, they'll have to be another trial. What really caught my attention, though, was it was an article out of the San Francisco Chronicle. Now, the San Francisco Chronicle, you would think normally is a fairly left leaning newspaper. I mean, we're no one's gonna confuse the San Francisco Chronicle with Washington Times, or places like that. But I just wanted to briefly read you something that I ran across from the San Francisco Chronicle. They tell a little bit about the murder. And they talk a little bit about how her body was taken 150 miles away. And then they said, I'm gonna see if I can find what I was looking for here. Yeah, she says transgender advocates make a big mistake when they argue that the teenager was not guilty of deception, or that Arroyo had no obligation to tell sex partners about her gender. What these advocates, in effect are telling transgender teens is, it's okay to play with fire. Long. Let's let's let's back up and talk about this a little bit. Because this issue of trains of hiding, and I know of deception has come up before and it comes up in a lot of ways in the transgender. So I want to talk about that from the start. Let's take, let's say for a moment that you are a fairly new person. And you are just starting the transition process and you're seeing a therapist, and the therapist says to you Well, what we want you to do, is we want you to live in your new gender. So that way, you can see that you're going to be successful in your new life. Exactly. And we want you to tell your family, and we want you to to get your job processes straightened out. And we don't want you to tell anyone what it is that you're doing. Okay, hold it right there. At what point does that become deception? Well, in my book, there's no deception there. And this is something that's being a CISSP. This is required as part of your transition process. There's no attempt to deceive. But from the outside, I can see how it looks that way. For

It's the the key issue in this Rahho trial. And it's something that I think any transgender that's out there has got to really think about, yes, there have been a number of sex workers in the last few years who have been killed over this exact same issue. Remember, we talked about one in Austin a couple of years ago, and they found her body dumped in a garbage container? Well, that turns out same same basic issue. They said they they pay gave her money. They brought her home. They didn't realize that that quote she was he when they found out they killed him. Well, in Texas, and this in that particular case, those people were convicted and they were sent to prison. But here in California, they're going to have to have a retrial. So they're going to have to go through the entire process again. And again, there's always the chance that maybe they won't be able to decide again between December between murder one or murder two, and maybe they'll get off again. So now there's a reasonable chance these three boys, three, three guys are going to get away with it. Yeah. I mean, that that's a reasonable, that's a reasonable assumption. And it's a big issue. I think any transgender out there has to really think about, and that is, if you're dating, if you're in the dating process, where are you in your relationship? Are you do you plan to tell if you're a sex worker? Obviously, that's a much bigger issue. I honestly can't imagine though. Jimmy, how you could be how you could pick up a sex worker and not know they're transsexual or say not know, that transgendered. That's beyond my comprehension. I
