Everything is pre arranged pre negotiated, and you're really not going to get that hurt. God forbid you do. Your partner's gonna get you the help you need. It's all there is to it. Abuses done with the intention of causing harm. As employees negotiated ahead of time and agreed upon. Abuse never is SM play enhances the relationship between the players abuse damages their relationship. SM play can be done in the presence of supportive others, even at parties given for this purpose. Abuse needs isolation and secrecy. SM play has responsible and agreed upon rules abuse lacks any rules as in play may be requested or even eagerly desired by the submissive. Nobody ever asked for does or desires abuse sorry. SM plays very erotic. Abuse is not erotic at all. SM play can be stopped at any time for any reason by either party with a code word. A victim cannot. A victim cannot stop their abuser unless they fight back. SM play the dominant keeps their emotions under control and abusers emotions are out of control. After SM play the submissive often feels grateful towards the dominant. A victim never feels grateful towards an abuser, right that's right. And these are basics people. These don't have to just be SM That's right. These are rules for meeting people. Also. I mean, if you don't talk about things, and you don't agree upon things, and you can't stop any type of action from one party to another, then you're moving into a real scary realm called abuse. John and I did a little intro on the tape. You're gonna hear some oops and ahhs and yeah, we'll edit that out, which we never did. But that's okay. That's what makes it fun. And that's what makes this show fun. You bet. These are recorded right there their names. I didn't write their names, but they are two people from the Montrose Counseling Center, who agreed to come on the show and give us some information on abuse. Predominantly same sex abuse. So whenever you're ready, punch button will roll the date. Okay.

Because we've had a lot of clients who present with with issues involving domestic violence. I also in my capacity as an educator have encountered this issue frequently. So it's been one that I felt the need to research and get up to speed on and have been doing that for a year or two now. So good.

Now, you say you are a counselor at the Montrose clinic before or therapists on the therapists. Counselors? Yes. Now you are therapists there before you started working with your, your, your group on with lesbians.

Yeah, I was there before I started doing domestic violence work. And I now run a group at the Counseling Center for Lesbian survivors of domestic violence.

Did you have to take certain classes or what what? What did you have to do to go from that to there?

Speaker 4 29:47

I did a lot of research in professional journals. And there there is not a lot to be honest with you. There's not a lot written about gay and lesbian domestic violence only in the last two or three years. Have we seen much of anything at all in the way of written material or research conducted on domestic violence in the gay and lesbian community, but I read everything that was available. I also collaborated with other community mental health facilities in other locations in Los Angeles and Boston in New York City, who already had domestic violence projects up and running, and got some ideas about how we could get a project started at the counseling center in that way.

Did they give you any ideas as to how long it would take them down? To get to that point? Where or do y'all see a light at the end of the tunnel? It's basically I guess, what I'm trying to say?

S

Speaker 4 30:45

Well, I think the light at the end of the tunnel is beginning the process of educating our community about the existence of gay and lesbian domestic violence and what to do about it. And in that respect, yes, I think that we know a lot more about domestic violence in the gay and lesbian community than we did three years ago, more people are responding to the issues involved. I'm getting more and more folks who call and say I need some help. I need to get into a group for individuals who are battered. There is a program here in town called pit the pivot project, which works with batterers. And that project now has a gay and lesbian component, so that they work with gay and lesbian individuals who are batters. So there has been a lot of a lot of progress made in this area, in the last year or so, in Houston. And I think there is a light at the end of the tunnel, it's going to take a lot more work, to educate the community, and to educate service providers who are not part of our community about the issues that affect gay and lesbian individuals. But certainly I think there is a light at the end of the tunnel.

Let me ask you a question, though. How common is it for a, an abuser to come in and say I need help.

It's not uncommon, okay. It is also not uncommon at all, for a court to tell an abuser, that that person needs help. And then they access services, either at the counseling center or pivot project, or really, for dealing with battering issues, those are probably the only two places in town that that services can be provided other than individual private therapists.

Okay. All right. Let's just start with the basic stuff that you and I always do. What is the difference between SM and abuse?

How do they deal with an SM relationship as opposed to this? Or how would you deal with an SM relationship involved in this situation?

Well, I guess another question was, have you ever dealt with an s&m relationship?



Speaker 4 34:00

I think I have one client who was involved in an s&m relationship and also had domestic violence issues involved. I guess how I would deal with this is by saying there can be domestic violence in the context of an SM relationship. But SM is not by definition, domestic violence, right. And it's a because of the conceptual issue that you mentioned. I would work with an individual who is in an SM relationship that is violent, the same way that I would work with an individual who is not in an SM relationship, but is in a violent relationship. And, and that is we try to work toward empowerment of the individual who is being abused. We try to work with the batterer the abuser to change his or For behave, because hitting people and other forms of abuse are learned behaviors. They're not some sort of reflexive reaction and their behaviors about which people have choices. So if they can choose to do them, they can choose to not do. And that, in a nutshell, is how I would address those issues.

So you're basically what you're saying is, is that in SM is different than abuse? So you handle it differently. Right? Exactly. You handle abuse, like abuse, and you handle s&m, if you can handle s&m? Absolutely, exactly.

And I think one thing that's really important is abuse can happen, no matter what role you may play in an s&m scene, you know, the bottom can abuse the top can abuse the butch role. So it really doesn't matter at all, you know, somebody smaller can be abusing somebody that's larger. So it doesn't necessarily follow the roles of an SM relationship.

Not at all. Basically, what we've touched on here, and I forgot to bring the information as the actual definitions, like abuses, not abuses, isolate isolation plays usually out in the open and discussed about abuse is, non consensual, consensual the violent act of rape be with a partner or with without your partner, you know, Stranger usually involves drugs of some type. SM does not involve alcohol or drugs. That's basically what we've hit on here. And I guess what we brought you all in for us to get more information on the abusive side.

One point that I would make is that I think we take some risks when we when we talk about rape being a function of some sort of impairment through chemicals, because lots and lots and lots of rapes take place, that that are not where there isn't a chemical prison. So I just wanted-.

Thank you. Well, I don't write as a sexual offense. It is not, in my opinion, it's not domestic violence. It's not abused. And I understand in some cases, you will have an individual that is sexually assaulted by their partner.

It's very common in domestic violence situations for there to be right, or some other similar, sexually based act.

J

John Benoveve 37:37

Well, then let me ask you a question. I don't know how they handle that in a heterosexual relationship. But considering that they do not consider homosexual homosexual or lesbian relationships, as being legal or any are valid, how do they handle that? That form of rape?

I mean, I'm not talking about our law system or government. Any any laws that are there to protect the victims.

Should it should be treated in the exact same way that rape in a heterosexual situation would be treated? And under I've worked with a number of individuals who have been raped by their partners in violent relationships and the police process those charges, although I'm not sure they yet take them as seriously, as they might take an incident where a heterosexual was involved in being right. Although, you know, in the context of marriage, if someone is raped, I'm not sure the police always take that seriously. But but I've certainly worked with clients where the police took the charge process the charge, and prosecutors were willing to go forward and prosecute a charge of same sex, sexual assault.

Well, that's really nice to hear. It really is.

Speaker 4 39:05

The prosecutor's office takes a very, very dim view of sexual offences. And they are pretty non discriminatory and how they prosecute those offenses. They they don't place much emphasis at all on the fact that it's heterosexual or homosexual relationships.

What is the percentage of men to women in violent and domestic relationships? Are there more gay men being battered or more gay women? Is it equal? Which?

Okay. Within the gay community, what is the percentage or do you know if any of the percentages of gay men being abused, abused versus gay women?

J John Benoveve 40:06

Before you answer that before you answer that? Earlier, you said that they aren't doing any testing, and they're not doing any research would any figures that they had be accurate?

S Speaker 4 40:21

I think that what I said was that there was not a whole lot of research that had been done. What research has been done, suggests that domestic violence is experienced in the gay and lesbian community in roughly the same numbers, as in the general population, and that's about 25 to 30% of the population. And those numbers have been true for gay men. Right in in the research that's been done, as well as for lesbians. So there's, there doesn't seem to be an indication that there, there is more domestic violence experienced by gay men than by lesbians or vice versa.

J John Benoveve 40:58

I guess that would go back to to what we were saying earlier before we started the day. That is something that's learned. Yes. Because that it has a general effect on the whole population, not just a certain group of people.

Yes.

Okay. All right. Let's see. We talked about the Houston area women's shelter earlier, and most, most lesbians and probably gay men would turn their first candies, people also turn to the Montrose counseling clinic. Do you want to take them off the quiet?

J John Benoveve 41:43

Well, she's the expert.

S Speaker 4 41:49

The Montrose Counseling Center is a community mental health facility. And we provide with a primary outreach to the gay lesbian, bisexual and transgender communities. And we provide

counseling services for individuals who are survivors of battering. We do provide some services for batters as well. We do not have the capacity to provide any shelter for individuals who need to get out of a dangerous situation. And the only resource entail that is available to lesbians and gay men. In terms of shelter services, is the Houston area Women's Center. Okay, they provide very limited services for men and general services for lesbians within their larger population of women who have been battered.

Okay, here's my question in in the context of describing an abusive relationship, they say the batter or the abuser always isolates their partner from the outside world. Yet, I also read later on that you can not only go to the Houston area, women's shelter, but friends. And my thought on this is if these people are being drawn away from their community, how do they have friends? How do they have anyone to turn to besides the current shelter?

And that's a very real problem.

Especially in the SM community where there may be a sense of isolation in a very limited community.

Absolutely, there may be even more isolation and I think there probably it's fair to say there is for individuals who are in a violent relationship within the SM community. I think we're
