They want our political support, talk about supporting our agenda, but do nothing. For example, I have received many promises over the years that the Houston gay lesbian Political Caucus was going to add transgender to their mission statement. Well, it's been 10 years since I received that first promise, and we still aren't in their mission statement. Now I hear there was talk of the issue being raised again, fully half of the items on the legislative agenda we took to Austin, or on behalf of the gay lesbian community. I'll be watching closely to see whether we made a mistake in doing that. And whether the promises made by the H GOP say are worth the air use to make them. And it's it's you know, I've been around too long to believe anything that anybody tells me in the gay lesbian community. I'm at the stage saying show me and I'm fed up with not only with the with the Chamber of Commerce, but with the HU LPC and with PFLAG, with some of these organizations that have had 810 12 years, the learning curve is over. I am announcing that as of today, I am boycotting every business associated with or supportive of the HDL CC. Until such time as they stop discriminating against gender variant people. I invite anyone who feels as I do to join the boycott. I suggest we accept the inclusion of transgenders in the mission statement is proof of their intention to bring segregation to an end. Okay, now I can hear people saying wait a minute, Sara boycott hurts her friends almost as much as it hurts the segregation is yeah, sometimes that's totally true. And one of the key complaints heard of the civil rights movement was the weak support of their supposedly allies. A running joke develop that a liberal is a person who leaves the room when the fight starts. I have no problem with putting pressure on our supposin allies. It's time they made their distaste of gender variant exclusion, loud, clear, and most importantly, turned into action. Talk of support are talking about support is not a substitute for Action. Personally, I found this latest outbreak of transgender phobia to be very hurtful. I and 1000s of transgenders like me have fought long and hard on behalf of gay lesbian issues. Starting with my experience at Texas a&m In the mid 80s, all the way to the present day, I work tirelessly and publicly on behalf of gays and lesbians. Yet all these years later I find transgenders are still viewed as a part from and not as part of the queer community. It leaves me wondering if all this work has been for nothing, and whether I should even continue to support the gay lesbian community as an activist. I wonder if I shouldn't stay home 10 My roses and let the world go by I realize I'm just one voice of course. And I've been but I've been a vocal and effective voice. If the gay lesbian community is willing to let activist like me leave in disgust over what we perceive as segregation is to exclusion ism. The right wing bigots will have been proven right. Gays and lesbians do want special rights? After all, isn't the demand for equality for oneself? While refusing the same equality to others? The definition of special rights? Yep, yep. Now, I've already gotten a response. And I'm not gonna say who this is from because this was sent to me privately, but I want to read part of this, okay. I know that my students see him, I want them. Okay, here we go again, wanting to add a group of people who for the most part are not even gay. And although some live as lesbians, biologically, they are still male. And so thus whatever pathological psychosis is going on. I don't want to deal with it. Pathological psychosis. As far as I am concerned, they are straight. Still, I see no damn need to change anything in either the organizations we've been discussing. Now you can argue all day that the homophobes placed us in the same category as the transgendered people. I say that their problem not ours. Imagine that one for a minute. I certainly do not. And yes, I suspect that there is indeed some prejudice there you think? I don't think a bunch of middle aged older men dressing as women is something I want anything to do with. Sorry, not now. Not ever. My attitude is in sync with Dr. Stan Rubino of Stanford University, who by the way, this is a study that's being referred to as paid for by the family, the family coalition. It says, who says that homosexual behavior is a slight alteration, but transsexualism and transgenderism are psychotic and pathological.
