And, but I still don't think we've answered some few people's concerns about the particular article entitled gay life gay death. Now as a person living with HIV positivity, I just spent 39 days in the hospital, not all 100% HIV related, but somewhat so I didn't find anything to take exception with our our comments in there that he draw similarities between act up and queer nation and other organizations as being radical and this and that, these are merely observations, I don't see them as finger wagons, I don't see them as name calling. And he has actually, in my opinion, addressed a subject that I have been wanting to see in print. And that is that division that does exist, whether people want to believe it or not, between those that are HIV positive, and those that are not, I know what the statistics say, about 30 to 35% of gay males have had themselves tested for the HIV virus, and a large significant amount of those people who have not had themselves tested, they run around saying that they're HIV negative. And they place ads and columns that say they want a partner that is only HIV negative when they themselves really don't know. And he discusses this whole subject and, and the divisive pneus that is it brings to our community, and that we're living in a medieval type of existence and a modern day plague. And I think it's an eloquent piece of writing, I invite anyone who's not HIV positive, who takes exception to this, to go talk to someone who has been fed up with this disease for more than just a little time, I'd love to talk to him about it. It's a good, I appreciate it, I think the bulk of the article actually is very personal statement as to the the anguish that we suffer in the divisions that we create, I think he was very brave to say this, let me just say, from a very personal point of view. You know, here I am a political activist, I know better. And yet, you know, I have seen hypocrisy in my own dealings with people. When it comes to HIV, I one of the things that's so interesting is how when someone tells you their HIV status, and you might have sexual relations with them, you do treat them differently from the person that you don't know. And it's funny how we even play these fictions with ourselves. And we do create divisions, and I've had relationships with people that are HIV positive, and and my status currently is negative. And I've seen that hypocrisy and me when I don't know. Maybe the level of safety that I use is slightly different from the paranoia that sometimes exhibits itself when I'm dealing with someone that I know is positive. And and I think that and I think, to pretend that we don't have to deal with that fear. Is is is really is very fake. I think that I think the fact that we are nervous about addressing the division that exists, I think, by the fact that we don't do that I think we make the problem even worse. It's an uncomfortable dialogue I've had this

dialogue with with people that I have dated that have a different status for myself. But I think it's a dialogue that needs to be said. And I thought Andrew Sullivan handled it eloquently, because I think we're all awkward about this. And I think, you know, I know that the issue often comes in this as an issue first, even positive people deal with in the sense of, do I really want to date a negative person. And we agonize over that. And I think that I think that it's okay to talk about that. And to be awkward about that and to get over those fears. And I think you do yourself a disservice if you don't have a dialogue. The other issue he talks about, he talks about act up, but actually you want to you might want to follow up on what I just said, because we can talk about act up in a minute. But I think that Andrew Sullivan probably wrote one of the most eloquent articles. As far as the vision in our community regarding this this virus. I think probably the last thing we need to say on his comments on act up and queer nation is he calls them radicals. I don't think there's either a member in either one of the groups that would take exception to that. Just recently, the director of the National Institute of Health said that because of groups like act up and queer nation, medical science has went further toward a cure or a treatment for HIV and AIDS than would have been the case otherwise. So you've got someone in the enemy's camp, the Republicans camp, saying the same thing that you've got This conservative gay man saying that this very radical HIV positive queer myself is saying. So you know, and Andrew Sullivan says that it's like, Yes, he does. He says, Thanks to act up, burrows welcome, cut the price of AZT. And he said he would not have happened otherwise, what he does go on to say is, he is uncomfortable sometimes with the way that sometimes act up tries to reduce the gay movement to slogans. And, and, you know, you may disagree with that, but that's part of the dialogue. And, and what I say to that is, you know, what I say to anyone else, if you don't like the news, go out and make some of your own. But, you know, be smart about it, don't don't attack the person that's sometimes in our camp, and don't attack let's notice, not attack our own first, let's not devour ourselves from within this take care of the wolves that are at the door, and not worry about the, you know, the lambs that are already in the house. So at least listen, I you know, I think at least listen and talk. Because I think we will become stronger as a people. If, if we can do that. I think silencing, you know, we saw this when PBS would not show tongues on time, they were silencing us, we should not silence one another. And it's very important for us to allow free expression, even when we're uncomfortable with the thought. That's okay. At least if you allow someone an opportunity to say what they think and believe you can deal with them more honestly and more effectively. And you don't have to spend any time guessing with what type of person you're dealing with. So I'm looking forward to attending the dinner and let's get very close to the dinner. Is this something that people need to consider because Delaney is saying

Martin Delaney is a very informed man and he's with Project Inform, and their number can be reached by calling direct resistance in San Francisco, they publish a newsletter that is available, Martin Delaney can be found writings of his in many periodicals. I encourage anyone to read everything that he writes. The issue of AZT is one that most newly diagnosed HIV positive people find themselves battling with very soon after they're told that they perhaps need to consider the use of anti retroviral AZT is very controversial. There are some medical experts who have no faith whatsoever in it, there are others who swear by it, I do think we can say that we have proven that AZT in the original recommended 1200 milligram daily dose was not beneficial to the AIDS patient. And it certainly wasn't cost effective either. latest studies would indicate that AZT, with a combination of DDR, or DDC is probably the most effective use of AZT, the most encompassing test to a study that has been done, says probably that AZT will not increase your longevity, but will only push back the date in which you become symptomatic with AIDS. But what you don't often hear then at that point is the amount of side effects that its toxicity may bring to you. So it's not a blanket. Subject that or a drug that you automatically should take, once you learn that you have reached the point that your immune system perhaps needs some help. It's an individual decision, your doctor may tell you definitely you have to have it. But I would encourage you to investigate it. There are many people who swear by it, there are many people who swear against it. To have the sources that are available, in addition to the project informed are two periodicals that are available, and they cover many different treatment issues. The first one is AIDS treatment news, and it's published twice monthly. And it's available out of San Francisco also. They have a one 800 Number for subscriptions, and that is one 800 Treat TR e a t one, two, it's an excellent publication. They cover many aspects of HIV AIDS. And the other periodical that is available is treatment issues, which is published by the Gay Men's Health Crisis out of New York City, and you can call electoral systems, I don't know why I can't find their number right now usually have it, you can call directory assistance in New York for Gay Men's Health Crisis. Or you can write to them at 129, West 20th Street, New York, New York, one double O one, one, and ask them about a subscription to treatment issues. So that's Gay Men's Health Crisis newsletter out of New York treatment issues is its name, or AIDS treatment news, which is published out of San Francisco and subscription information can be obtained at one 800 T r, e a, t, t, r e a t one, two, it will bring you more information. So you can make more and better informed decisions on your own health care regimen. I think it's very important that everybody be a part of that decision making process and not just leave it up to your individual physician.

What could happen here is the case management system for all the different service organizations in Houston was kept in a database at the Alliance. As that's how the money was decided should be spent. It was a good good way of doing that. The board of which I was a member of supported that. The case management system, which legally according to the US Federal Government still belongs to the greater Houston AIDS Alliance was essentially stolen by the county, Sue Cooper and her Hinch people. When judge Lindsay tried to make the Alliance defunct, she and her people took the case management system over to the county and they have not returned it. The case management system is the confidential records of each and every person that has went to an aid service organization and said this is my name and address and phone number in here are my needs. Where do I turn for this and that I'm not going to accuse judge Lindsay of purposely doing something with that system in order to hurt someone that's HIV positive. But the fact of the matter remains is we don't know where it is. We don't know who has it. And we don't know what's being done with it. So if if you have been in the case management system or a client of any of the aid service organizations, you might want to write or call judge Lindsay at 7558379 or any of the other Commissioners commissioners Lee ever so Radek, or Fantino. Actually, the phone number I just gave you is Lindsay's fax number, don't waste your time on trying to speak to him personally. But you can call down to Commissioner's court and arrange to speak in front of them, make it known to them that you don't appreciate your identity being at just anyone's disposal. But Judge Lindsay's fax number 7558379, or you can call for County Commissioners Court and find out the mechanism that you need to put in place in order to speak to them about this issue. It's should be of great concern to anyone who is HIV positive and been in the case management system.
