I wrote these notes from Susan Palmer, the gay lesbian activist of the century because she told me to say that that's amazing. Palmer Thank you, Jamie. Susan Palmer, activist extraordinaire. Love you, honey. Okay. Yeah, lots of important stuff here. Re call this meeting. It's a citizens review panel. I'm not sure exactly what it's called. They met at tsu, the Thurgood Marshall School of Law at 9am Until Gosh, some god awful time like six or 7pm, eight, maybe. There were I believe there were nine people on the actual committee and the committee can I mean, yeah, let me try again. The committee members included Jean Harrington, three people from the Gay Lesbian Political Caucus, one of them in nice Parker, and I'm not sure who the two other people were. Anybody knows they can certainly call me and tell me. Nancy Bunin from the clock rate foundation. Norm Thompson, I think Nora might have been from the GPA shakes. I really don't know. Susan Donovan from she's a president of Texas, ACLU. Greg Latin, the lawyers, National Lawyers Guild, Clyde Williams, one of my favorite lawyers, Greater Houston Bar Association for human rights. And there were those were the Committee of the council members, actually the panel hearing the testimony, and they were there to ask questions. They're going to do something with their findings. God only knows what they're going to do something with them. And it's up to us to tell them what to do with them. So we need to make sure that their findings get spoken up about you know, we can't let this incident die down or else it will happen again, mark my words, dine Williams Saturday. What is the 12? September 12. Mark my words we have to talk about this early. It's going to happen again.

There is it's kind of cigar shaped so the only entrance is the entrance. The only entrance and exit is the entrance and exit which we entered into this area. The only way to get out of there is to go back from whence we came. And there are two or three different streets we could go on the most direct route would take us around the Astrodome just around the main outside of the Astrodome to where all our cars were parked in what I lovingly referred to as the holding pen which is supposed to be called the free speech zone as if we don't have free speech anywhere in the world. We have to be locked up in this little free speech. So needless to say, at the time that we arrived at this it was dusk seven maybe eight. I really don't know couldn't tell you at eight o'clock. There were police Okay, let me tell you how many police there were there were about there was helicopters. There were 40 to 50 mounted cavalry police officers, police officers on horses 40 to 50 of them. Let me repeat that again. 150 police officers total 46 buses that were there. I'm talking big school buses buses to haul back protesters away. That's right. Before we even done anything wrong, you know, and I'm saying they were prepared that not only were they prepared, we were set up

based on the buses didn't get there at the clinic defense to pick up the people who were obstructing the doorways until after, after they'd been removed and satisfied. And I

She said that the clock rate Foundation had observed 14 demonstrations during the RNC. And this is a quote, by and large HPD acted appropriately during the entire convention. That is, however, nothing I have even ever observed, prepared me for what I saw that night. And then she, you know, call for a full scale investigation and something to be done about this information. We have all this information, and nobody's willing to hear it. nobody's willing to do take any action on it do anything important about it. Sheila Jackson Lee was at the sang. She came probably for about an hour. So read the newspaper. But she was there. I'll give her that she was there. Vince Ryan sent an emissary. Not to say that we don't love Vince Ryan. But he sent a representative at least Sheila Jackson Lee Shut up in person for at least, you know, an hour or so. And she did speak and she said that I quote. I see the need and I'm going to put in brackets here for justice because she was talking about justice. I see the need for justice for the August 17 events. And then she went on to talk about how Tsu was a really appropriate price place to have this council because of the history that goes with Thurgood Marshall School of Law and Thurgood Marshall. Okay, let's see lots lots more important, though good stuff. Okay, let's see. Let's see. An ACLU neutral observer. There was a straight husband and wife couple that were there. And the guy said, I don't I don't know his name, frankly. He said that HPD tries to justify their assault on the marchers. By overestimating the size of the protest. They kept saying there was over 2000 people there. They kept trying to tell us to leave and wouldn't let us that's his quote. Kelly Martino also got up and spoke at this event. And he said that he he called this an institutional hate crime. There was a lawyer who went over the police report of the investor police investigation, and the lawyer friend found 14 inaccuracies. 14 things that wrong in the police report about about the incident. Like I said, pages and pages of notes I have on this. This is just ridiculous week. Supposedly the police gave us a warning to disperse. I was there I was in the very front. They gave us no such warning. Josh Wells was kind of a coordinator during this. During this he was a coordinator for the ACTA, RNC national and he's from LA. And Josh was talked to by a police I think it was a sergeant or so sergeant came up to Josh and said, Josh, get your people out. And I didn't say Josh, he said, You're gonna have to get your people out of here. There's there's things brewing, you know, tell your people to disperse, just said, that is not my job. That is your job as a police officer to give us an official warning or not to the guy never did. Josh then took his microphone and said, the police are telling us we have to go. And over the megaphone thing he had a bullhorn, he was telling people well, if we have a crowd of even 1500 people, one bullhorn in the very front, which is to say the back of the demonstration, visually at this point, right up next to the gate. That's not going to get people moving. There was a die in about 50 women were laying down passively in front of the police officers. It was ridiculous. As you can tell, it was pretty emotional was pretty emotional for me. And I have pages of notes on this. And I'm trying to think of something that particularly that I could tell you that would be really important for you to hear, did

And he had set up with two separate meetings with HPD after the march and basically both were cancelled by HPD. And the term they used was it was unnecessary. Let's see. We we talked about the police report that they had on it the police a Paul Molins from coordination Houston said, talking about the HPD report it in no way address brutality or homophobia, and it had no way justifies police action. Also the HP there's a number of inaccuracy eight HPD said that the uniforms were the normal uniforms. They had their soft hats on the whole time. And yet we have video of them in riot gear with helmets. So it's ridiculous. And I saw him getting out the riot gear when I was there. I mean, they were in riot gear, a lot of them HPD said we had more than 2000 people there. We have, we have pictures, we have videos. It was incredible. It was just incredible. If anybody out there listening was there, you're certainly welcome to give us a call. We do have somebody here that can answer the phones,

Their position was that discrimination based on sexual orientation is quote, no more legitimate than that based on race, gender or religion, and quote, these are two of the same publications that a year ago refuse to run paid ads praising gay and lesbian personnel serving in the Gulf War.

The two organizations battling over Colorado's proposed constitutional amendments to repeal and prevent lesbian and gay rights legislation have issued financial information under the state disclosure laws. The amendment supporters, Colorado for family values raised about \$135,000

as of June 30. For the same reporting period, the pro gay and lesbian equal protection campaign had raised about \$220,000. A Denver Post News poll in mid August a 501. registered voters found 54% will vote against the measure 36% will support it and 10% were undecided.
