couple paragraphs just the way it is. says by the time preliminary hearings are over, El Paso County prosecutors will have gotten a total of four distressed and shamefaced girls to confess that a fellow teenager whose legal name is Sharon Clark, had consensual sex with them for months while posing as a boy. Clark, who's now 20 faces one to eight years for each of the 11 felony counts she is charged with, including sexual assault, criminal impersonation, and sexual assault on a child. If found guilty on all charges, the young woman could wind up serving as many as 32 years in prison. Whoa, while three of the counts against Clark are based on age. Two of the four complainants were 14 and Clark was 18 when some of the sex occurred. pedophilia is not the crime the state is emphasizing. For prosecutors, the key issues are gender, and informed consent, a concept from the medical arena, the courts have increasingly applied to sex. The district attorney claims that in effect, Clark rape the other girls by withholding a crucial piece of sexual information from them, right. The case which was set to go to trial, August 24, is unique. Because it may be the first time anywhere in the country that law enforcement has treated gender deception, as something tantamount to rape. But it is one of a growing number of instances around the country in which people have successfully portrayed themselves as sex partners is of the other gender, the majority being biological females, convincing younger females that they're male.

And in the heated arguments, Shawn apparently said something to the effect of well, I'll kill you. So she took it as a threat and reported to the police as well. She should yeah. Okay, fine. So, the police go to look for Shawn and don't find them at home. And instead what happened is they found him in a nearby shopping mall, patted him down and discovered a Colorado Id made out in the name of Sharon Clark. According to police, Sean admitted he was female. And that night, a pair of policewoman decided to bring Shawn up on charges of criminal impersonation and sexual assault,
