The city of Santa Fe passed a resolution in support of Senate Bill 91 Earlier this month, activists believed the boycott following Colorado's passage of

Amendment two may have helped the New Mexico rights campaign, both by sending Colorado's business across the border to New Mexico and by posing a threat of lost income to estate heavily dependent on tourism.

If the constitutionality of Colorado's amendment two is upheld, it will overturn local gay and lesbian rights ordinances. Cities and towns in Colorado are asserting their autonomy. In the meantime, the citizens of Telluride Colorado have approved a human rights measure which includes gays and lesbians by a vote of more than three to one. A newly formed coalition called Voices in unity is actively organizing for other municipalities to pass gay and lesbian rights measures. In New York City. several restaurants are joining the boycott. They're refusing to sell popular flavors of Colorado made Celestial Seasonings herb tea, such as sleepy time or grandma As Tammy meant, at the request of the group New York Boycott Colorado, however, the FBI is investigating the allegation by Celestial Seasonings that New York Boycott Colorado demanded a \$100,000 contribution to its campaign against the state. And that if celestial didn't pay, the company would face an all out boycott against it in New York, New York Boycott Colorado at no time demanded Celestial Seasonings give us \$100,000 To stop the boycott action against them. Chip Duquette is a spokesperson for New York Boycott Colorado. He declined to be interviewed about the controversy but read a prepared statement that includes the following Celestial Seasonings is intentionally making an absolutely false statement in order to incorrectly color the motivations in New York Boycott Colorado and to create a smokescreen that obscures their very conservative refusal to speak out against an amendment to as a matter of policy, New York Boycott Colorado does not accept money from Colorado companies. We do recommend that they spend such money in their home state toward the legal battle against amendment to or to educate Coloradans about the amendment. Its true meaning and its ramification. Duck it says New York Boycott Colorado attempted to work out a compromise with Celestial Seasonings at their request to avoid the boycott. Dakota such a compromise would have to involve celestial speaking out against amendment to celestial chairman and co founder mo Segal declined to be interviewed for this report. But celestial spokesperson Catherine Bessemer says that boycott organizers made it clear during a meeting with Seagull that in order to avoid being a target of the New York boycott, a large contribution was expected.
