It's an outstanding interview says he is one of the winners of the transgender Pioneer Award from law conference. But apparently I'm there was some discussion on the show about the idea of how to select the therapist and what to look for in a therapist. And it helped her make up her mind. She's that was what she needed to do. And so I feel pretty good when those kinds of things happen. Okay, you know, we've, I've even gotten letters from a couple letters, emails from folks who said that, uh, one in particular that I kept, where the young woman had said that she was trying to basically wondering whether she should commit suicide. And she thought she was the only one, and it hurt the show. And so happened that was a night that we had Linda and Cynthia Phillips on the show, oh, God, once you got the right show, you're really upbeat. And she's now seeing a therapist. And those are things that really keep me going. Because it's like, you know, if you reach one person every time you do a show, hey, this was worth doing. It's worth staying up till 3am. So, so where are we going from here? Well, I want to, there's so much of this, we'll have to do this in stages. But the last show in the last or last 30 minutes, we started to talk about what your rights are. And I mentioned that a lot of people don't know what their rights are. They what they know about their rights is what someone else has told them. They've heard it in discussion. Maybe they've attended some sort of a group in some ways as well, our rights are this, but they don't really know. And I had brought a lot of material. And it's I happen to show his jam packed and we only we we went through like two hours with material in 20 minutes. So I'm gonna go over some of it again, in a little bit more depth. Because I've been asked to do that. I've received numerous emails from people who said, Boy, that was really good, but I was third more of it. So I wanted to start with that. And we'll start off by talking about the US military. Now, yes, there are transgendered people in the military. There are people I know several people who are transgender, who are decorated combat veteran. But they were not transgender in the sense that they had not started the transition or anything while they were in the military. And there's a reason for that. And it's because President military regulation, bar appointment, enlistment, and induction of any individual who has undergone sex reassignment and disclosure of one's desire for sex reassignment is grounds for immediate dismissal. Okay, I'm not surprised at that. I'm not either. However, this discrimination has a very far reaching effect because transsexual people can be denied appointments, enlistment or induction or dismissal from the military. And in fact, if you become romantically involved with a transsexual, you are subject to potential dismissal. Why as right, the effect of such dismissal, it could be no less damaging than dismissal for being transsexual yourself.

Is this is this part of the old thinking that thinks that a transsexual person is automatically gay? Yes. And so if you're having some sort of relation with it. Oh, okay.

Yeah, it makes you right now, brother, this specific rule that first of all, I guess you ought to know, there's a whole code of what's called the Code of Military Justice. And I've never seen it but I've talked about it isn't that an oxymoron? I've never seen it but sharing Stewart was a

But I've talked about it is it that an oxytocin that I've never seen it but Sharon Stewart was a military judge. So I've talked to Sharon Stewart about this at some length. And she has told me some horrifying stories about gays and lesbians and transgenders in the military in a match and the particular rule that's involved here is a rule it's called. I love this the agenda tour, urinary urinary system. I can't even say it on the chin, it's a combination of genitals and urinary system. What the hell is that about and it's rule 2.14 called genitalia they actually have such a rule. Now you think somebody had to sit around and think about this rule, when you like to have been a fly on the wall the way the day they thought it is no kidding. The causes the causes for rejection of appointment and enlistment and induction are major abnormalities and defects of the genitalia such as a change of sex, a history thereof, or complications, residual to surgical correction of those conditions. So that means, even if you are a post surgery, suppose you had surgery at 18 years old, and now you decide to join the military, if they find out that your post operative they'll bounce you out.

It also sounds like if you get your dick cut off and shot off in an accident on a hunting expedition, they're gonna kick you out.

Well, their definition of man is pretty much what happened between the legs of the wheel sounds to me. Their rationale and implementing this regulation is based upon the determination that quote, enlistment of transsexuals would not be in the best interest of the individual or the military service. Transsexuals are not considered psychologically or sociologically suited for military service. And they require continuing sophisticated medical care. Because of the absence of organs and glands normally present in an individual at birth. I have no idea what the hell we're talking about.

I don't think they do either.

S Sarah DePalma 36:31

I have no idea. I mean, you have to take hormones. After your surgery, your hormone level is lower than what an average woman takes for birth control pills.

Okay.

So I have no idea what they mean. It's beyond my comprehension. But that's the rationale. We

are talking about the military and you know, military intelligence is an oxymoron. What can I do? Okay, now then, let's get to the subject of getting you booted out. There are no specific regulations that require the immediate discharge, dismissal or separation of a service member seeking sex reassignment. Let me repeat that there are no specific regulations. Now, if that's the case, how do they do it? Well, the vagueness of the military regulations utilized in separating service personnel permits easy discharge, dismissal or separation without cause. Because they use the term gender dysphoria, and they use transsexualism and then say, that means the person could be sexually or romantically involved with a transsexual. Got that. So if you're transsexual, you're you're, you're acting to another transaction.

Okay, is this the old gender dysphoria thing? I know, you've talked about you hate that term. I hate it. I would love to see because it's sort of like it's sort of like the sodomy law in Texas. You know, nobody actually gets arrested for it, but it's used to keep gays and lesbians as the police force.

Well, in this particular case, what they've done is they have gone to what's called the Dionysus the Diagnostic and Statistical Manual, the DSM was called in until recently, the DSM was to transsexuality along with things like pedophilia, and obesity allergies, was a really good chunk. Now, the new DSM is doesn't have us lumped that way. In fact, it's no longer even listed as a psychiatric problem in the DSM though, having said that, you're talking about the US military, who is only recently discovered that it is not 1970. So it asked the military to catch up.

Well, they haven't stuff as learning. They're still they haven't gotten over having blacks in the in the military.

Well, you were caught with Colin Powell there, they would have caught up sooner or later. What thing? Yeah. Okay. Now, here's something that you need to know that if you're in the military, you cannot, you want to be very careful about going to a VA hospital and saying to what's, let's say you completed uterus or detour of duty, perhaps you've been in the military, I don't know, either 10 years, you decide that you want to use your GI Bill, for example, and maybe use some of the medical benefits at a VA hospital. Okay, be careful. There are now documented cases where they have gone back, changed the discharge papers on a person and disqualified them from using the VA hospital for anything what? It's right. That's right. It turns out that there are what are called military boards. They're called boards for the review or discharge or dist or dismissals. And I'm not going to go into this because it's like two pages of what these boards are. But essentially, these boards have the right to go back and change discharges. I didn't think that was wasteful. Well, what they can do, what they'll do is they'll come back and say, Well, you were in the military under fraudulent conditions. Therefore we don't have to do

anything with your discharge either. And so if you want to, if you will decide that you want to go back and use the middle of VA hospital for any of your transsexual things, even if it's for hormone, be careful. They may do nothing. I know, I know people who are using your VA benefits to get hormones. But there apparently are now documented cases where they've gone back and say, Oh, no, we don't have to depends on basically, it's like anything else in the military? You know, they know you're gay. But will they do anything about it? And maybe Same thing here, they may know your transaction? Will they do anything about it? Depends. Do you catch the wrong person? Yeah. You know, if you get someone who decides raises, think about it.

Well, that's right. Now, we started to talk about civil rights the last time and I'm going to take a little time and explain a couple of laws. One in particular, one is called Title Seven. Title Seven of like a house loan. It's the Civil Rights Act of 1961. Oh, okay. Now, as amended by the Equal Employment Opportunity Act of 1970. I love the government terms. You know, this prohibits discrimination in employment in federal, state and local government and in the private sector based on race, color, religion, sex or national origin. Okay, okay. Notice that sexual orientation or gender identity are not in there.

And it's that no, you can't lump that under sex, correct.

That's exactly where we're going with this. The majority of recent decisions, both the district and appellate court levels have have said again, and again, Title Seven does not apply to transsexual rights. Okay. And examples of discrimination, which are forbidden by this law include things like maintenance of sex segregated advertising, remember, we used to see help one male, one is female, newspaper, but you don't see it anymore because it's illegal. Oh, the establishment of different retirement ages for men and women. I remember that women retired at 62 men and 65. Right, that's illegal now. And separate and separate promotion letters for men and women, or the refusal to treat pregnancy is temporary disability. Those are all illegal. However, discrimination based on changes
