Many people who are processors in this, or they're ever going to be your processors do not carry letters to the therapist because they're not seeing a therapist reason. However, if you will contact TAC, which is the Texas Association for transsexual support, they have a letter that craft wrestlers can use that was drafted by Phyllis. It's not as good as letter that you get from a therapist. But it's something for you to give an officer if you were stopped. Because your driver's license is not going to picture in the driver's license will look like you do in the officer is going to think right away. What's this person trying to pull? So if you're not going to be comfortable enough to say to the officer look, officer, I'm a crossdresser. And that's all there is to it. The cross, most officers will understand that but most bosses I know are gonna have the guts to say so to have this letter from tax would be a help. Now, for those of us those of you who are transsexuals or think you might be transsexual, or you're seeing a therapist about gender dysphoria. There is a letter that you can get from the therapist. And there are several different versions of this this one actually in fact happens to be known as the Phyllis letter, the Phyllis Phyllis letter because it was actually drafted by Phyllis in Dr. Cole. And here's what the letter says. Those letters to verify and you put in your your male name, AKA your female name, is currently under our treatment ethic at the clinic for the neuro endocrinology and I'll never say that in row chronology condition, commonly referred to as gender dysphoria, or transsexualism. A period of cross limit living commonly referred to as the real life test, or change of living full time in the male gender identity as a man to living full time in the female gendered identities a woman is required as a prerequisite for both those who choose to undergo sex reassignment surgery, as well as those who may choose full time hormonal, non surgical options. As part of this real life treatment process, this person is required to live in work to mix with family, neighbors, friends and co workers in the female gender identity as a woman. So you can hear this paragraph there they are explaining then why you're you know.

It is viewed as therapeutic and appropriate to facilitate the transition for the pre surgical and for the non surgical person to be allowed the following new pronoun, in this case she and her Wow, a legal change of name, in this case, money. A legal correction of gender identity on identification, in this case to that of a female gender identity is a woman they can hear Phyllis is drafting on that part, because that's the legal part of it. In our medical opinion, a change of name without a corresponding change from an M to an F on her routinely used identification document is incomplete. If you're talking about driver's licenses here, include compromise your ability to successfully complete this treatment requirements, and possibly incur significant emotional distress and discrimination. Please feel free to contact us for any additional information. In this particular cases, I'm going to the Rosenberg clinic to hear information Rosenberg clinic. Now there are about three or four, I've seen probably three or four different versions of this depending on what therapists you go to. But I carry this in my purse all the time. And that's because I really need to work because I just it's like a security blanket. If if you don't have a letter of some sort of explanation, whether it's from a therapist or whether it's from tax, then you better be willing to explain to an officer what's going on if you get stopped. If you don't do one of those three, one of those things, you're really going to have trouble with an officer because they're gonna say what are you trying to pull your mind understandably so?

So to answer the question for the email that I received, no, it is not illegal to crossdress in the city of Houston. I think we've talked about that now several times. But on the other hand, it is wise to take precaution in Jimmy, I think you have a pledge.

And I have been speaking with Nancy Bure Meyer, who is the Senior Political advocate of for the Human Rights Campaign. And she's of the opinion that this bill has a very good chance of passing. Partly because it was one of the co sponsors of this bill in the Senate is Bob Dole. When is it coming up? Pretty fast. It's on an expedited track she told me which is another reason that they think this bill is got a good chance to pass unlike most bills, this is going they they she's convinced this is going to fly through committee because the Republicans control the committees and they want Bob Dole get what he wants for an election campaign. You have to understand how politics works. First of all, this defense this this act is clearly anti gay lesbian bisexual is more importantly though, Bob Dole needs to shore up his support with the right wing with the religious right. Now you remember there was this big flap over the accepting money from the Log Cabin Republicans? Oh, yes. Well, there's been a lot of criticism from the right wing people new republican party saying Bob Dole was soften homosexuality. Okay. Well, what they're saying is, well, you accepted the money, right? So now Bob Dole has to show the right wing people to he really is anti gay by God. And it's a calculus decision on his part that gays and lesbians probably we're not going to vote for him any way for so he needs to shore up support with a right wing. And here's the perfect bill to do it. Now, let's talk about what this bill does is the first thing the bill says that marriage is legal union between one man and one woman, as husband and wife, and a spouse as a husband, or wife of the opposite sex. You know, low, pay attention, folks, if you're gay and lesbian, and you want to get your, you want to have a legal marriage, not if this bill passes. If you're transgender, it raises some very interesting questions. No kidding. If you're like me, for example, and you've had your name change done and your gender changed on my licenses, female, all my stuff all says female, I'm living with female decided, suppose I chose to marry this person. Could I do it legally, I don't know that if this bill passes, I probably couldn't look low. So transgenders, who are sitting up and saying, Oh, this is a gay lesbian Bill ain't sell. On the other hand, if you're really gay and lesbian, you think I'm safe?

Well, that's the other part of this bill. And this is the dangerous part of the bill. Takes a little explanation here for a second, there is a part of the Constitution that's called the Full Faith and Credit Clause. What it is, what it means very simply, is a law that was a marriage that took place in one state is recognized by all states, or divorce that took place in one state is

recognized, but all states, etc, etc. Okay, yes. Okay. This particular bill would say that works against the Full Faith and Credit Clause, it provides that no state shall be required to give effect to any public act of any other state respecting a relationship between persons of the same sex that is treated as a marriage under the laws of such other state. So if you think you're going to go to Hawaii and get married, and that your marriage is going to be recognized here in Texas, forget it, because if this law passes, Texas can say, oh, no, there's a law in the book says we don't have to recognize that marriage, and we won't.

It is being supported by Newt Gingrich and Tom DeLay what used to arise, it is on expedited passage, it is expected to sail through committee HRC is very worried about this bill. I've talked to folks at the end the National Gay Lesbian Task Force. They are very worried about this bill.

Well, that's part of it. Yes, in that you're right. That's a very politically astute observation. First of all, it puts Bob Dole on record saying no, I am anti gay. So because the whole Shimon gay vote anyway, right. So so so Christian coalition folks, vote for me see, I'm not as bad as cats. I'm not as liberal as it says I am. Okay, which is very strange. But that's the thinking here. And you're right, what? Bill Clinton in a position of vetoing the bill, right, which would make white pro gay. I don't know. That's what they would push it. Now you have to understand right now, there are 24 states that have introduced bills to deny recognition of same sex marriages. Yes. In two states, Utah and South Dakota have already approved such a law. Haven't some states rejected 17 states are still looking at it. Now, here's what's going on. In Hawaii, you got a situation where the Supreme Court is likely going to say a gay marriages ought to be illegal. The Hawaiian legislature doesn't want to recognize the bill. Oh, okay. So you got a judicial bill coming down with this with a Hawaiian legislature saying, We don't want it? It feels because this bill passes, it could essentially invalidate anything that happens in Hawaii in Hawaii, right? I mean, it's a very strange right out of existence. Now. Here's something else to consider. Another reason that they want this bill to pass concerns federal benefits. The federal government extends benefits, rights and privileges to people who are married in generally accepts a state's definition of marriage. This bill will help the government defend its own traditional his words, traditional and common sense definition of marriage and spouse. So no domestic partnership law right in the federal government, because this law would prohibit it Interesting. No, I get that. Yeah.

I would shoot it right down the toilet. And finally, what it would do is there's something called the Family and Medical Leave Act. Now what this was was a bill passed in 1993. That said, if you're about to have a baby, in, for example, and you want your husband to stay home with you, for this fit, they had to allow you to take the time off, right? You didn't have you wouldn't get it with pay, right? Well, now, for example, you also have to hold your job, right? So there are lesbian couples who are hurt doing this the artificial insemination right now. It would deny them this family we owe. So you understand how discriminatory now this law would be if this passed. This is called the Defense of Marriage Act. That ought to tell you something. Now, the lead person on this bill is Senator Nichols, who I believe is from Oklahoma. We tried to speak to Senator Nichols when we were doing lobbying, and he told us flatly, there were no transgendered people in Oklahoma.

Bingo, there it is. That's it. So folks need to get on the phone with your legislator, whoever your legislator is in the house or in the Senate, you hopefully know who they are. You need to get on the phone with them and say, I do vote. You have got to work against this Defense of Marriage Act. Now, one thing that you really need to understand about this bill is if it passes, folks, you're the any idea of same sex marriages are over. That's right, get over this.
