I'm pleased to have an interview with Randall Kinnear and Randall Kinnear is our current Gulf Coast drummer 2000. And he was just involved in the international Mr. Drummer Contest, which was held September 14 through the 17th in St. Petersburg, Florida, at the Suncoast Suncoast resort hotel. First off, Randall. Welcome. Welcome to after hours.

Thank you. Thank you for having me here. I appreciate it.

I'm glad you could be here. And you're here this weekend. This is a tape broadcast, but you're here for the Lone Star drummer contest where you're a judge. But I wanted to talk to you about your experiences at the International Mr. Drummer contest. And first off, I'd like to congratulate you, you came in as first runner up, which is very, very good. And I think it was out of eight contestants. And I'd kind of like to get your feel on how you feel that the contest went there in Cal. I said California, I'm I'm going back to where it used to be held in San Francisco. But it's just this was the first year it's been moved to St. Petersburg, Florida. So tell us how did it go out there in Florida.

The contest itself was very, very well done. We had no extra time. From the minute we got there. We were busy. And they kept us going. But it was all day Friday, all day Saturday, and it was over on Sunday. And that was I mean 24 hours a day, we had something to do. So it was very busy. But we enjoyed it. And it was a great bunch of guys, the thing that I liked about this contest is that there were eight regions, which meant there were probably five or 600 people that had competed up to that point to get to the regional and into the international level. But the great thing about it is that there were eight regions for the man and then eight regions for the boys. Also everyone had a boy this year. And that was the first time for that. The drummer boy contest, right, right. It really was a contest this year. Yeah. And the great thing about it is that every guy in there could have won, no one was ahead of anybody in any spot. Nobody was the leader going into it. It was one of those contests where no one knew who was gonna win until the very end. And they were great guys. I've never competed in the contest where any of them could have won, and I would have been happy. So it was a good experience. I would encourage anyone to enter it. It was fun.

Right? Thanks on that. If those of you who don't know, as far as the categories that they go

through during these contests, they do an interview where that's pretty much a 2030 minute interview with other judges that talk about different questions in the leather lifestyle in the drummer lifestyle. You'll do in onstage speech and leather image, a fantasy and jockstrap contest. So, tell us about each of these categories, how you were scored, and kind of go through each and tell us how what's your favorite ones? Were some of your likes and dislikes.

My favorites? Oh, yeah. Well, I when the interview and the onstage speech sections, and the interview is I think ours were anywhere from 20 to 30 minutes. And if they had extra questions they wanted to ask you, they brought you back in and talk to you a little bit more. I think I was in there about 35 minutes. And they were seven judges and I think four of them were former international title holder. So they pretty much knew what they were doing. And then another man owns zoo studio. So he had been around the drummer contest for many years. And then Mr. Marcus, who is a reporter for the Bay Area reporter, was also a judge and the first chosen international Mr. Drummer Ray Perea was a judge. So it was nice to see 23 years of span of time in there between people but the interview is not easy. They ask you questions to find out how you would handle yourself in front of an audience or in a situation like I'm doing right now. And they put right they put questions to you that they put you in situations and ask how you would handle those situations. So it pretty much is designed to find out more about you more so than what you know about the history of something. One of the questions As they asked me was one of the judges said he was a 14 year old game man who had been abused, he was on drugs. And he asked me for help, what would I do? First thing I told him that I would do is put him in contact with the Department of Human Services, or B, or I would become a CASA volunteer and help him get help. Because in Oklahoma, you cannot take a an underage child into your home for any reason. And that that was the main thing he was looking for, to see if I knew what was going on. So he liked your answer. Yes, he liked my answer a lot. And there are questions such as that they're geared to find out about you and not so much just fluffy questions. You know, they don't ask what kind of a tree you'd like to be or, or anything like that. They're I mean, they are a very tough question. The onstage speech, I don't have any problem giving speeches. So I can walk on three minutes before and find out what I'm going to say. And I just say it, I talked about, I asked them, I asked the audience if they ever wondered why we did contests? Because that is a question. I think everyone needs to ask themselves. Why do we do these contests? And what do we get out of it, we get very little out of it, other than we just do things. And we want to do things for the community. And so that was, that is a speech that's a minute and a half. And so you can only talk for that long. And after a minute and a half day, the microphone goes dead. So you have to get everything set in that minute and a half. I think I spoke for a minute and got off the stage before I said something stupid. The fantasy part I got second and fantasy. My fantasy was they divide the regions up into sections and give you a theme for each region. So you know what your theme is going to be our theme Gulf Coast region theme was cruising. So I had guys in a bar cruising each other and it ended up well, I'm not going to tell you how it ended up anyway, it ended up in a in a fantasy. Well, anyway, I was giving blowjobs on stage big time and they and they were behind a wall and they sprayed whipped cream on my face to make it look you know like something and happened and I was there licking whipped cream off my face and the audience enjoyed it. And so it was fun. The fantasy that one was men, motorcycles and muscles, I think and he had a motorcycle on stage and made love on a motorcycle. So it was it was really good fantasy, the jaw category. I came in fifth and jock. It's not my strongest, strongest category, but I did I did. Okay, I did okay, and I lost the contest, I think by 12 points overall, which was not bad. And I placed higher than any other Gulf Coast drummers ever placed, which was really nice. Yeah, I enjoyed that part of

it. But it wasn't so much that placing I wanted, I really wanted to do well. And I wanted to represent the Gulf Coast region as well as I could. But the thing for me is that the international drummer contest gave me a venue and a place where I could be myself. And they never lied to me about that. I talked to the owner of the contest at the International Mr. Leather contest in May. And that was the week after I had been selected Gulf Coast drummer and I asked him just exactly what he wanted. And I said that we can send the first runner up if you don't want me, so let me know. And he said no, no, this is what I want. And he never lied to me. They were honest and truthful the whole time and I felt the contest itself was honest and run Honestly, I never ever thought for a minute that there was any shady business going on. They presented themselves honestly and and we had a lot of fun. And it was a good experience altogether. It was a very positive experience.

There is a state level contest also that I went to Oklahoma drummer in February when Gulf Coast drummer in May and then went to nationals in September. So it's all in like an eight month boom, boom boom. period and you do fundraisers and you raise money to go at cost. It costs a lot to go I think I spent about \$5,000 getting there and that was from Oklahoma to Gulf Coast to Florida but it was many that I raised in the community I had a great deal of support from the leather community and I belong to a leather club All the Tulsa uniform and leather sneakers Association and they gave me a lot of money and a lot of support. But I also got a lot of support from the heterosexual BDSM community. I don't know why the straight men love me. I don't know why that they do. And the straight women, they just they threw money at me. And it was it was and the lesbian community in in Oklahoma, they were very supportive. So I also have to say that the drag queens, the female impersonators raised an amazing amount of money. And there was an artist from New York who gave me a great deal of artwork name IOC Smith. And if it hadn't been for him and selling all of his artwork at the the fundraisers I had, I would not have gotten there, because it does cost an awful lot. So I had a great deal of support from several individuals, what I would tell people to do when they run for a contest is never to doubt who is going to support you and always ask, all they can do is tell you no question, right? That's exactly right. And ask them for help. And they will help you but had it not been for the drag queens, I wouldn't have gotten there because they raised a lot of money. But we've always worked really well in the Oklahoma community and Dallas community as well, where the Gulf Coast contest is held that Leatherman and the drag queens do a lot of work together. And we're all out there to raise money for different charities and things. So I never hesitated to ask them to do anything. But the main thing I encourage people to do is say thank you. Not and I'm gonna say right now, email, thank yous are not appropriate. You need to write a letter, you

need to get out the typewriter and write the letter and send a formal letter of thank you to people, emails are not appropriate. But you need to learn to say thank you to people, and we don't do that in the community enough?

You know, just by the way, their eyes shift all over the place. So their body movements. We're not stupid. When we judge these contests, we know what we're doing. And you have to have a personality you have to bring the audience into Do the contest, you have to gain the audience's support. You have to say something from your heart about the community and you have to have a background in the community. You can't just walk up there and say, Hey, I look good in leather. I'm gonna win this contest. Although some people do that it doesn't happen that way. I just turned 44, the week after the contest, but I was not the oldest one. It's, it's all that clean living and cocoa butter. But, but I was not the oldest person in the contest. There were boys who were almost my age, and several, and there were I think, or three men that were older than I was. So it is not limited to 20 year olds who have perfect bodies and perfect teeth and have the what I call Mardi Gras leather, which is just leather, that's just would look better in a Mardi Gras, right, it's a show and they don't really wear it and they run out right before the contest and buy all this leather. You don't have to do that you can wear a pair of jeans and a T shirt and a leather vest to your contest. And if that's what you are in leather than you should be in leather, I think we get way too extreme on our leather. It's it just looks like you're putting on a production. And that's when it does become leather drag. You know people don't like to say that. But that is when it becomes live or drag.

It was we did get extremely close because we had to do everything so fast. And we spent, we spent literally I think 23 Out of the 24 hours a day together. So we didn't sleep a whole lot.
