The man had had a had a warrant for my arrest warrant. The warrant came as a result of a grand jury indictment. The officers job is to serve the world and take me to jail.

Well, the thing about it is, in most cases, that is not true. In most people's lives, and arrest happens, something like lightning strikes. Yeah. And it happens at a street corner and it

happens in a shopping mall or something of that nature. But there is nothing you can do. That's right interfere with the officers decision to take you to jail. As matter of fact trying to talk yourself out of it has several downsides from the position of your future legal defense turns out that keep your mouth shut, say nothing because whatever you say will be twisted and will be crammed on your legal throat at the appropriate time. So shut up. If the officer is going to arrest you. Say Yes, sir. Yes, ma'am. No, sir. No, ma'am, to valid questions. And if you think a question is not valid, that I think I'll reserve answering that till I talk to.

The most common way that the phone calls that I get most commonly what happens is they get there at a traffic stop. The opposite run wants and warrants and discovers is a warrant. You turn that one right. And now they're on your way to jail. That's the single most common way that I get it. The second one is they're coming home from the bars and Saturday night, Sunday morning and they get pulled over for DWI, or public intoxication. It I don't care if you're intoxicated, they going to take you in they don't care who you when.

I hear we couldn't break this habit. But but he got that in the manual. That's right. It's not an unwritten policy. Now you're transgender people all over the city freaking out, first of all, they're going to be stripped of their female stuff, then they're going to go into male facility, and then they're going to be called sir. Well, I mean, I mean, if you want to cause a transgender person to transfer to suicide in jail, or to start ripping their hair out, that's how you do it. But none of them none of this is aimed at being demeaning. Why are you waiting? Or do seminars?

Unless we have a complaint, though, is just hot air. And it makes no sense for you to be sitting home with bruises on you and nothing being done. So I really, really want to encourage you whether you're gay, lesbian, bisexual, transgender, whatever the case may be. If you are the victim of a hate crime, for heaven's sakes, report it. Yes. I also want to follow up on something in the last show, we had a guest from Montrose Counseling Center who they had won a grant to work with victims of hate crimes. They are Gary, Gary. Well, I'm pleased to report that at least one of these victims has gone to the counseling center and has reported very, very good things back about the Montrose counseling in their knowledge about transgendered issues. Hey, great. So I you know, sometimes we have people on the show, we never know whether it's a follow up or not. I just wanted to make it known that there aren't that there is some place that you can go and be able to get this done. And we are starting to head out here. This is the Gay Men's Chorus of Los Angeles with a song called diversity and it seems like a good way to go out. If I got the CD, right. I think you-.
