Hi, this is Russell here with Jack McGeorge from Washington DC. We're here to talk about the National Coalition for sexual freedom. Jack will talk Tell me about yourself first. What's your background in the scene? And how did you come to be involved with this coalition?

For Russell, I've been playing for about 40 years, I'm 49 now and I started playing somewhere in Iran, eight or nine years old, I've been involved in the organized BDSM scene. Since 1985, I would say approximately so that 1314 years now.

Right now we're at the living and leather conference in Dallas. And this is a conference to you know, all the very serious players come to, to, to rub shoulders and elbows and you're sitting here at the NCSF booth. And so you're you're pretty much on top of the NCF, SF organization, and really helping to promote it here at The Living and leather conference, you hear lots of people conversing here in the vendors area. Tell us about that organization.

Sure. NCSF was started at over a year ago by Susan Wright, in New York City with Susan's idea, and it was a very good idea. January ish of this year, she was looking for some help. And several of us in the Washington DC area, largely the Black Rose group there, we decided that Susan had a really good idea needed, the help was worthwhile. And so we gathered a group of folks together to give her a hand that has been augmented now my other folks in the New York area, and surrounding country, we have NCSF staff all over the country. NCSF AI is our lobbying group for the BDSM community in the leather community, in the larger sense, are not a social organization. We don't hold parties, we don't do workshops, in the traditional sense, like little does. Our job is to take in effect legislation and to affect people's attitudes towards BDSM.

So this is strictly a political advocacy group. That is correct. That's fantastic. I mean, to me, it's really exciting. And also it seems to involve more than just BDSM groups on board. And it's kind of a genuine coalition of different sexual orientations. Is that correct?

Yes, it is. We welcome people and we advocate for people of all orientations, and quite a few varieties of activity. You can't be everything for everybody. And a Georgia shotgun approach isn't going to be effective. I, we do not differentiate by orientation. We have a focus on BDSM. However, we also take and advocate on behalf of sexual minorities of all varieties.

And you have in fact, lobbied in Washington DC, with Congress, staff and other

folks. Yes, we have. But that is not our prime focus at this moment. I lobbying with Congress is most effective when there is something specific to lobby about. The chances of us getting pro BDSM, or pro sexual minority legislation introduced and through Congress is pretty minimal right now. This is a raw political climate for that. Yeah. What we anticipate is that we may be able to discourage negative legislation, and that we kind of anticipated was unfortunately likely to happen. Our efforts are probably best spent now in two primary areas. And that's the news media and the courts. In the news media context. We look very carefully at the media all over the country. We have NCSF reps that monitor major dailies all over the place. We're always looking for more by the way, where we see articles that have an anti BDSM slant or an anti sexual minority slant. i We put these up on our weekly Media Watch report every Friday, this goes out. And we encourage people, we synopsize the article and encourage our readers to take and write to the letter to the editor to straighten out misperceptions or to present our side of the issue and you also

yes, we do at the end of that media update is a how to write a letter to the editor. We make it very simple for you. I are a person who does that as a law longtime journalist himself, and he's done an excellent job of here's how to make this thing painless.

We are. We think this is very important. One of the things that we need to be effective at lobbying is to show that there is a problem. Now, many of us are well familiar, anecdotally that there's a problem. But when you're dealing with Congress, you're dealing with the news media and whatnot, you need to be able to quantify it, we need to be able to define it, how many people are being discriminated against? And what in what form does this discrimination occur? So this data is not well collected. As a result, we are doing this survey. We have about 900 respondents so far, we'd certainly like to get over 1000, so that we have a statistically valid sample as possible, to get a sense for just exactly what is happening. Have people lost their children, have people lost their jobs? Or there's been hassled over it? Or they've been physically assaulted? I want to know, what's, how has the negative actions in the sexual context how they occurred?

And I would think that that survey might also not include not just employer discrimination, but perhaps state sponsored discrimination

as well. Any kind of discrimination that you feel has occurred to you as a result of your sexual

practices? We want to know about it.

Yeah. Well, that's great. And there are lots of people in Houston, they're very interested in being active either as a media watcher, filling out the survey, sending money into the the organization, you'd mentioned that a small amount of funds had actually been raised. We've raised

about \$10,000, all together. Most of that in the last few months. By virtue of a couple of clubs, the user activist groups on the local level, I in DC, DC SMA, was very successful on behalf and raised several \$1,000 and weekend fundraisers. We've had other clubs in DC do that we've had National Weather Association chapters have been kind enough to to give us grants of money. And this money is being used for good purpose. NCSF is all volunteers. Nobody profits personally in any way. This money is not used to fund you

to travel all over the country. Is it a nonprofit corporation at this point we are

currently taking and preparing those filings right now, we did retain an attorney and accountant to handle that side of it. We know something about lobbying. And we know something about our activities. But the ins and the outs of 501. See this data the other thing, we got to go find professional help to do that. So that's in progress right now. We'll incorporate and the scheduling the IRS as a 501 C four lobbying organization. We don't want to fool around. Let's see what we are.

Well, on the four kids assumption within house, so to speak, within the leather community, and anybody in the sexual minority communities, we have a number of things that we can give you right now. We have a pretty good guide to how to write a letter to the editor. We have a very well done guide to communicating with Congress. This is both in correspondence and in person. This tells you how to when to talk to Congress, to your congressmen, they represent you. And they will listen to you. Usually the aides knew what to focus on speaking with the aid, not the congressman, how to do this, when to do this, how to organize your material, how to make the presentation, you can get a lot done. Congress likes to be visited. I, we have a media tip sheet. Their media tip sheet, is what to do when the newspaper calls you, or the radio station calls you and wants an interview. They want a quote from you. For many people that have not ever dealt with the news media, this is a very intimidating thing. And we've taken we laid out for you and what to do and how to prepare for that, so that you can speak knowledgeably cogently and get your point across. We also have a list of other publications that you can get from us. Some of these are in preparation. And some of these we can send you right now. We have an s&m community issues book that talks about the issues that pertain that we will have to defend ourselves. Let me rephrase that we would need to be knowledgeable on to defend ourselves from attack, we have looked at many people's anti sexual minority material. And we've done a lot of analysis of that and identified the themes that seem to recur throughout this material. The issues book addresses those themes, and what we suggest as the what language you use, and how should you approach approach. Responding to these, we have a briefing book. And Briefing Book is a summary of our Media Watch reports, our issues, briefings and the NCF actions and tells you about what is NCF doing, right. We have a legal summary book, which is that's in progress, which focuses on the cases that are currently before the courts that pertain to our community, what we think about them, and what we're going to do about them if anything, most cases are not appropriate for us to join some cases, we may be able to affect legislation versus law by affecting the decision of the court by filing amicus curiae briefs. I'm not a lawyer. That's the right guy to get a lot of details from. But that's our plan.

I would assume so but I'm not an expert on the British legal system. Irish system is based on

British common law. So I will assume there are close parallels. I shall assume then, that if there was appropriate to file briefs in front of the court papers of one variety or another, that that was done, but I don't have those details.

Right now. It seems like what's happened over in Great Britain, which might well happen here is that, you know, there's a very substantial court case on record in a substantial precedent to basically legalize BDSM as a legitimate form of sexuality.

And we do not want that to happen here. Right. One of the problems with the spanner case was that they are British cousins were not well organized, to cope with it, when it went down. They had to gear up, and that put them behind the power curve. We don't want to be in that situation. God forbid such a case occurs here. Let's hope not. If it does, we want NCSF to be up and running and staffed and functional and effective beforehand, then we can step right in and know what to do to actually affect the outcome. That is our goal.

Well, right now there are all these you know, legalizations, of fellatio, and animal sex and, you know, various other activities, it seems, you know, an easy step for at least state legislatures to start legalizing BDSM. And I mean, the danger is very, very palpable. It's already there. It's you know, it's already happened in a number of states and a number of other countries. And this is a very serious problem and a potential, you know, nightmare for a lot of us. I mean, for instance, if you can be fired or not fired from a job, because your sexuality because you you're open about your sexuality, and that sexuality is illegal, therefore, you're considered a felon or something. You know, you're a non citizen immediately. And that's a real danger in the society right now. We have a very conservative legislature in the state of Texas we do and also in the nation right now. You know, I really advocate this group by the way. What else would you like to say about the group?

We have all sorts of other things that we're doing one of our areas, concerns, Child Protective Services, and the problems that arise? Well, the courts are well meaning, and they're looking to protect children. And we think that's wonderful. And very important. I went through a divorce some years ago. And fortunately, it wasn't as messy as some. But I certainly know I that it could have gone a very different way. My wife could have gotten upset about my activities, and was our activities. And she didn't, but other people that's happened, and allegations are made, and the courts, in their effort to err on the side of protecting children will discriminate against unfairly against people with practice alternative lifestyles, we want to make sure the courts are aware of the difference between the criminals that so often come through the courts that are practicing spousal abuse, yes. And those people that are practicing BDSM, in a safe, sane and consensual manner, yes, those things are very different. Very, unfortunately, the courts don't

see nice people very often, the court see criminals, right. And it's no surprise that a judge is going to have a an innate negative view, for in the judges experience. Unless they're one of us. They, they've only seen the negative side of our scene,

and the fact that so many of us are afraid of discrimination, makes it all the less likely that anyone will develop a well rounded understanding of what we're actually doing. Yes, I mean, we there's a lot of private community building, and intense and very, very ethical education going on with this small sexual minority in the SM BD community, if you will. But there's not as much of a media outreach, a media connection, a legal and political arm of this community that we're building, which by the way, is really a wonderful group of highly educated, capable, and I found, for the most part to be very ethical, and also, not just individually ethical, but there's a peer pressure going on here that helps to weed out people who are of an abusive nature quite quickly. You know, if you come out to, we always announced the various groups in Houston. And that's the safest place to meet someone, and we are socializing our sexuality, and we are making it a positive thing. We're working very hard within our own little community, to keep our people safe, and to keep everyone happy, and to be within the bounds of the law. However, there's not much of an understanding of that, from outside of our small little community. We'd certainly like to help that to happen. I think this group would really do a tremendous amount of good and it would be a real strategic strike. Right? The PowerPoints that need to be contacted, the people that have the ability to illegalized our sexuality, will at least know how legitimate it in fact is.

Do I get someone to come to me with the movies? Or, you know, what do I do? I'm not feeling good. I'm feeling uncomfortable, insecure, frightened. But what's the main the main message we want to get out and a lot of what the book is about? Jealousy is an emotion that you can learn to manage into the world.

And not just individually? Is it possible to coach your partner or to manage the jealousy of your partner in a productive way without planning it? It's certainly

possible to help your partner with jealousy reassurance, makes a big difference for someone who's feeling jealous. extra attention and verbal and physical affection make a lot of difference. which means of course, that a really good sweat skill is being able to ask for those things. If you're feeling jealous knowing that it's okay to say I'm feeling a little bit queasy about this. I'm feeling a little bit insecure. Could you please hold me Could you please tell me that you love me you know, whatever it might be that would help you feel better. Being able to ask for that is a really important skill for being a good slot.

And so you do have to pay attention to making sure to meet your time commitments to give as much time to your relationships as they merit and to give some time to your relationship with yourself as well. Which can get difficult when you're trying to spend time with all your lovers and friends. Also, sleds run into logistical issues with Whose turn is it to use the bedroom? Or is it okay if we use our joint bedroom for for play with other people whose turn is it to use the toys. My partner and I ran into a small issue tonight when I'm up here at Dorothy's house in the country, with our toy bag in the trunk of the car. And he had a commitment tonight to use the toys that are in that toy bag. And we miscommunicated about where the toy bag was. I don't need it. I'm not going to be playing tonight. But I forgot that he needed it. And I drove off with the car with a

lot of trouble finding my tape recorder and we moved to a new house and we listened to one of the things that I was curious about was now when we do BDSM or, you know the deadly word Sado masochism, which, to most people's minds, in the popular culture, since that's what they see in films and movies. a real important point here in sort of the history of fluttery because the truth is that sexually active especially women have been floods have been treated as if it was really okay to abuse integrate them. Much as whoever thought it was okay to to murder Matthew Shepard. Many women have been murdered for being sexual against the rule. There's no question about that that happens out there. The truth is, I think that as a society, we have to take the responsibility for saying, Okay, are we going to like open up the society's values? Are we going to still go on hiding, you know, pretending to be am I going to pretend to be a nice lady all the time? Or am I going to get the word out there? That I am a proud and sexually To give person I can't change the prejudices of other people. When I was young, it was really kind of harsh because it was in the early 60s. People were very violently abusive toward openly sexual women. But what I learned was that the prouder I was of myself, and the prouder I was at my sexuality, the less those people want to mess with me.

You know, the farther along you get in the relationship, the greater a disappointment, a deal breaker like that is going to be so it's kind of best to, to get it out there on the table very early on a point that I wanted to step back and make, in talking with us pardon the expression the straight world about being a sloth or being non monogamous. I've found that the model that a lot of people have, a lot of people already have a model for the idea of a long term loving, committed relationship outside of marriage. And that relationship, in particular for women is the best friend. Most women are very comfortable with the idea of having a best friend, that they tell everything to they share with they spend a lot of time with you. You just say, Okay, have sex with your pets. That's the model. And they don't owe. That to me, and it's interesting that more attention isn't given to this, this this trend phenomenon as as a polyamorous model, because I think it's very strong in women's lives, they may recognize that in a lot of ways they connect with their best friends in ways that they don't even with their husbands, primary partners.
