That afternoon, ladies and gentlemen. The debate over whether to lift the ban on homosexuals in the military has to put it mildly sparked a great deal of interest over the last few days. Today, as you know, I have reached an agreement, at least with Senator Nan as Senator Mitchell about how we will proceed in the next few days. But first I'd like to explain what I believe about this issue and why and what I have decided to do. After a long conversation and a very good one with the Joint Chiefs of Staff and discussions with several members of Congress. The issue is not whether there should be homosexuals in the military, everyone concedes that there are the issue is whether men and women who can and have served with real distinction should be excluded from military service solely on the basis of their status. And I believe they should not. The principle on which I base this position is this. I believe that American citizens who want to serve their country should be able to do so unless their conduct disqualifies them from doing so. I have asked the Secretary of Defense to submit by July the 15th. A draft executive order after full consultation with military and congressional leaders and concerned individuals outside of the government, which would end the present policy of excuse me of this exclusion from military service solely on the basis of sexual orientation, and at the same time, establish rigorous standards regarding sexual conduct to be applied to all military personnel. This draft orders will be accompanied by a study conducted during the next six months on the real practical problems that would be involved in this revision of policies. The change cannot and should not be accomplished overnight. It does require extensive consultation with the Joint Chiefs, experts in the Congress and in the legal community, joined by my administration and others. We consulted closely to date and will do so in the future. During that process, interim measures will be placed into effect which I hope again sharpen the focus of this debate. The Joint Chiefs of Staff have agreed to remove the question regarding

one's sexual orientation from future version of the enlistment application. And it will not be asked in the interim. We also all agree that a very high standard of conduct can and must be applied. So the single area of this agreement is this should someone be able to serve their country in uniform? If they say they are homosexuals, but they do nothing which it violates the code of conduct or undermines unit cohesion or morale. Apart from that statement. That is what all the furor for the last few days has been about And the practical and not insignificant issues raised by that issue are what will be studied in the next six months. Through this period ending July 15, the Department of Justice will seek continuances. And pending court cases involving reinstatement and administrative separation under current department of defense policies, based on status alone will be stayed pending completion of this review, the final discharge in cases based only on status will be suspended until the President has an opportunity to review and act upon the final recommendations of the Secretary of Defense with respect to the current policy. In the meantime, a member whose discharge has been suspended by the Attorney General will be separated from active duty and placed in standby reserve until the final report of the Secretary of Defense. A new federal bill prohibiting discrimination based on sexual orientation was introduced in the US Congress on the first day of its new session. HR 431, the proposed Civil Rights Act of 1993. Unlike earlier attempts at national protections for gays and lesbians, is not an amendment to the Civil Rights Act of 1964, which protects racial, ethnic and religious minorities. That proposed amendment never came to a floor vote. HR 431 is a standalone measure dealing with sexual orientation, whether actual or perceived as a separate issue. In its preliminary form. It offers protections in employment, education, credit, housing, the sale of goods or services, public facilities, and federally assisted programs and activities. The initial sponsors of HR 431 are representatives Don Edwards and Henry Waxman of California, Patricia Schroeder of Colorado, Gerald Nadler of New York and open gays Barney Frank and Gary studs of Massachusetts. 83 co sponsors of the previous gay and lesbian civil rights measure continue as members of the current congress and can be expected to support hr 431. Nadler believes there is a strong possibility the bill will come to a floor vote in the House perhaps this year and pass the measure would no doubt have a more difficult time winning passage in the Senate. If enacted hr 431 would take precedence over local legislation and would nullify Colorado's amendment to which denies legal recognition of gays lesbians and bisexuals as minorities.

It's estimated that more than 3000 gays and lesbians visited Aspen, Colorado last week for the 16th annual Aspen gay ski week, dividing not only the city's residents but also gay and lesbian ski buffs across the country. Aspen was one of three Colorado cities with an ordinance protecting lesbians and gays from discrimination before all such protections were overturned in November when the state's voters passed amendment two. Among those taking the opportunity to visit Aspen during the week were both Denver Ku Klux Klan leader Sean Slater, who protested the January 15 court injunction delaying the implementation of amendment two and openly gay former major league baseball umpire Dave Pallone, who addressed the Aspen high school student body. Gay ski week, participants protested against amendment two with a candlelight march through the downtown area. The event attracted several 100 people.
