Another liberal associate of the Southern Baptist Convention, the Raleigh North Carolina pullin Memorial Baptist Church is currently pulling its congregation on the request of Kevin Turner and Steven Churchill to formalize their three year relationship with a holy union ceremony.

FDA testing has found the actual amount of DDC contained in the imported capsules to vary from none at all to dangerously high doses. Recent research has found that people with HIV who take DDC in combination with AZT live longer than those who take AZT alone, and as many as 8000 people in the US may be using the underground drug.

Martin, you will talk in your book about why psychiatry took the stance that it did on homosexuality. I'd like you to share that with us.

I think that a lot of these psychiatrists who fled Europe during World War Two, and came to this country were eager to be accepted as good Americans. They became something that can I think legitimately be called cultural police. He's in the 40s. In the 50s, psychiatry was invested with all kinds of authority by most Americans. And I also think that this is a suggestion Kenneth Lewis has made in his recent book the psychoanalytic origins of male homosexuality. Lewis has suggested that in American psychiatry especially, therapist never heated Freud's early injunction that they had to deal with their own bisexuality. Freud believed everybody had bisexual impulses. And his point was that unless a therapist analyzed analyze those impulses, the therapist was likely to project them outward and negatively and hostile Lee and American psychiatry never did except Freud's views on bisexuality. And so as a result, you have

psychoanalysts like Irving Beiber and Charles Zachary's writing the most savage, cruel, nasty things about their own patients who were gay. I mean, it really amounts to professional incompetence. If you read a burglar, especially from the 50s, or Bieber, from the 60s, I mean, the hostility drips and Lewis's point is that these men were so terrified of their own unexamined, same gender erotic impulses, that a way of distancing themselves from their own impulses was to, you know, denounce anybody who acted on those impulses.

I think it's changed a lot. I think there's still gray areas. For example, I wouldn't want to hang on a new vote by the APA. As most of your listeners know, I'm sure in 1973, the American Psychiatric Association dropped homosexuality from the category of illness. I'm not convinced that a vote today would lead to the same results. There is still a lot of homophobia within the profession. I just heard last week of, you know, 26 year old gay man in New York, because a friend of my lovers who just emerged from three years of therapy trying to get cured. So there are still therapists, and I suspect a significant number out there who are trying to cure gays and lesbians. On the other hand, and it's a big on the other hand, we now have a lot of openly gay and lesbian therapists specializing in dealing with gay lesbian clients. And obviously, these therapists are not remotely going to attempt anything like a change in orientation. All also I think the newest generation of heterosexual psychiatrists is somewhat more tolerant. Again, I wouldn't want to hinge on it. It's a very individual matter.

In Texas, the justice of the peace courts are the smallest courts in the land. In other words, we we deal with quarrels between neighbors like Mrs. Jones dog, dewes and Mrs. Smith yard and who is responsible. And Mrs. Rodriguez is fence gets pecans from Mr. Harris's pecan tree dropping in her yard and whose pecans are they I mean, they're after all getting sunshine on one side. So they have roots on the other. Those kinds of great in momentous occasion, marriages, marriages, a lot. evictions, a lot to truancy. The kids won't go to school, what is to be done about that, and that shows up in Texas law as a criminal offense against the parents incidentally. And HUD checks in the aggregate amount not to exceed \$5,000 In other civil matters not to exceed \$5,000 Is the jurisdiction the court?

I it was a Supreme Court case came down this week where Judge Thomas newly appointed judge Thomas said, essentially that if you're in custody, they can beat you as much as they want to, and you have no rights to complaint. Unfortunately for his position, the rest of the jurist went the other direction. I think Scalia joined him in part, but the majority opinion was that one can indeed be egregious ly beaten, and one has legal recourse, if that happens, that kind of strange composition to the court that the court is not going to have any consistency like at hand. And that affects what happens on the justice of the peace level. Because in these little corals that I mentioned earlier in these criminal cases involving hot checks and small amounts of what the Supreme Court of the United States says is the law of the land. And I think that as a justice of the peace, I am duty bound to follow the principles established by the law of the land. There are certain things that I think maybe, for instance, the increased degree of privacy, you know, if they actually arrested someone for 2106, would be trying my court. Wow. You know, 2106 didn't go to county courthouse to Class C court, which in the city of Houston is Municipal Court, except if one is busted by, say, a constable or a highway patrol person or a state agency cop, one would wind up in a Jaypee

court. So I would actually be able to rule on the infringement of the rights of privacy that might result from a 2106 Bust. Another thing that that people don't think about these things, but suppose you get beaten up by police officer. Suppose I mean, tonight, leading, leaving one of the clubs, you get pulled over and you're a passenger in a car and, and a police officer gets insecure and starts smashing you upside the head? Well, you could, of course, go down and file a complaint. Thank you. You could of course, go down and file a complaint with internal affairs and watch them shell game in your complaint falls through a hole in the table that you don't see. Or you can go to the district attorney's office and file a charge thing. And the district attorney passes it from one office to another office to another office to another office back to the first office, and you never quite get any satisfaction there. The third option is you could do as I have done many times filed a Chapter 42 section 1983 lawsuit in federal court, feeling your civil rights were aggrieved and that works takes seven years to get any satisfaction. And it's some of that is if Justice Thomas has his way will disappear quickly. Or as an alternative to all
