They say that, you know, They picked up flyers at the club, which had to do with a women's gathering and dance that prohibited men from attending with some hint of lesbian activity or something like that, you know? Well, first of all, that wasn't even an event at the Jezebel that took place at MCC church, you know, which, but they tried to apply it to the club. It's
