Apparently, the anti gay and anti lesbian hate crimes during that period was a second largest number of all the groups that they reported with the anti black hate crimes being at 73. During that period, also, there was a the numbers are across the board here, anti white hate crimes were there were 49, anti black, there were 73, anti Asian, there were seven anti Jewish 13 Anti Hispanic, there were 17 anti gay and lesbian. There were 66 which means during that period 19 That that six year period, there was 242 Hate Crimes committed here in the Houston area alone. And like I said, that was the anti gay and anti lesbian group was the second largest group right behind the black, anti black hate crimes during the six year period. And this is why we fight for anti hate legislation.
