The two people were 14 and 16. Okay, less than three years separating their age, which is statutorily important both of them and south side of the age of consent, because in Texas, the age of consent is 17. And New Mexico, the age of consent is 14 in Oklahoma, the age of consent is 16. And in Louisiana, the age of consent is 15. So the age of consent fluctuates in their neighborhood, but ours is 17. And for the purposes of man at crossing state line take team. But in this case, both the participants were south of the age of consent, so everyone had a good time, presumably everyone was consensual, except perhaps the mother with a 14 year old and, and she tried to make a stink of it. But they informed her lady, these two people are kids and there's no laws, right to apply as not even a journalist there's some kind of force or or coercion. In the extreme. There's nothing to do here. And so they went on about her business. And she went on to about, they went about their business, she went about her business until the 16 year old turned 17. And then she filed the charges as sexual assault of a minor. And the charges were accepted. And he was arrested and processed through his jail and had to make bond to get out. Now, he wound up in judge Jim bars court who promptly appointed him a lawyer at the arraignment and postponed other things until future date. And the court appointed a lawyer took a look at situation and said, You know what, you're both south of south at the age of consent, you're less than three years difference between your rights. This is this is relatively minor matter. But Michael did what young men do in these situations, I mean, my God had just gone through the trauma of being arrested. And so he decided that that he would just deny that the whole thing ever happen. And so the lawyer, court appointed lawyer worked on that theory until the lie detector tests kind of threw him for a loop of both taken up by surprise. He told the family give me some more money, and I'll do a better job. They gave him a couple of \$1,000 in the very next court appearance. i He Michael arrived a few minutes late after docket call. And so they had him in custody. And the lawyer came back and said you're going to prison because we're going to try this case today, and they're gonna give you 20

years. So I worked out such a deal. If you'll sign this six year deferred adjudication, confession. I'll again go home today. And you will be under probation supervision for six years. And he mumbled something about having to report as a sex offender and go to second, fender treatments and things of that nature and But Michael wanted to go home. So he signed the papers and he went home now this happened in December of 1997. A year ago, almost. He was court ordered to do eight hours of community service in December of 1997. But he didn't get a probation officer until December the 29th. In the holidays between Christmas and New Year's and there was no way to facilitate that that would become significant because later on they would say he had violated his probation terms of probation or did not do any hours

Those are the people who have political inroads into county governments. So those people who get the political acronym and so at some point, that counselor sat down and said, you know, if you You're in denial about your problem as a as a child molester, then you're not being cooperative with your treatment. And if you're not being cooperative with your treatment, then then you're not going to be helpful to your treatment and your probation is in jeopardy. I mean, it was pretty strong suggestion. And then comes the question, Are you a child molester? No.

And I can see 30, but 25 is hard to match. And so But at any rate, in November of 1998, Judge John Hughes, who took his original plea, irrespective of what the statute says, and protections built into it, and gave him that six years deferred adjudication probation, violated him and gave him eight years, hard time for one year, eight years hard time and reason I'll as as a sexual assault on a minor can carry up to 20 years, and the judge thought he was doing a favor given me eight years. Now, right now, according to the laws in the state of Texas, a conviction under the sex offender laws. If you get an eight year sentence, it means you must do an eight year sentence, there is no possibility of parole under those sentences. There is no good time afforded in those history sentences. So it's eight years and what's going to happen in

the next session, the legislature, they're going to pass the civil commitment laws, so that a single person can complain that you're a danger to them or their children. And you will be held in prison, beyond your Senate, perhaps for the rest of your life. Has a very serious, serious situation. So I found out that the judge was John Hughes, they call me after the fact and the sentence had been imposed. And so I said, Well, I'll just go down until John used to unravel the ball of wax. I mean, John Hughes was my criminal defense lawyer some many years ago in 1970. I got hard time and takes the penitentiary. So I go down to see John Hughes. I mean, we know each other I mean, I'm not an officer, the court didn't hurt me to export a jet. So I go down, and I confront John sheets. We good old boy for a few minutes. And as soon as he realized what I'm there for, he looks me in the eye. And he says, Raymond, this is a very dangerous man. And I said, What man, I said, we're talking about a kid. As a matter of fact, we're talking about a kid who was a below the age of consent kid. When this all happened. He said, Well, this court reacted to a very dangerous situation. And this was just not gonna go away. And I said, Judge, I am less concerned about the less than three years difference between this young man and his companion than I am about the more than 30 years difference between you and your wife, John uses 74 years old. His wife is about 40. She too, is a judge, incidentally. And that's okay. And so I could see that this was not going anywhere. So I started to leave and we went out in the hall. And as we were passing in the hall, and a youngster and I had gone in there at 830. And now it was after 930. I waited more than an hour, cooled my heels for an hour to see a judge who I've known for 35 years. I've known him for almost as many years as the difference between he and his wife. And so, his court coordinator came rushing up and said, Walter pink is here and judge stopped in the sense that I'll see him immediately. Let me tell you who Walter pink is. Back in 1985. During the referendum, yeah, a full page ad was taken out in Houston Chronicle. It was signed by Mark Twain didn't have anything to do with the real Mark Samuel Clemens or the real Mark Twain. I remember the document it was a scathing vitriolic. It was the worst piece of print media in my memory in Houston, Texas. I got a personal apology from the editor of the Houston Chronicle, and assurance that such an ad would never no matter what people pay for it would never run into chronicle again. The person who reserved space for that ad and paid for it with his operating account check was Walter pink. And so I have a feeling what's going on here is that the far right wing sex police have created a victim In Michael Williams, and they are digging their heels in. They're going to punish him because they can't get it. The rest of us thought he was 16. He was about all of the all of that is built in the statute, the statute and God save us from Texas legislature but the Texas legislature when composing these statutes built in all of the protections necessary to protect him from that kind of punishment, but you only get the quality of justice as you get the judge. Well, he's an idiot that and the judge has always not He's worse than that. Judge John Hughes is a perverted old man. Can this case be appealed? No. Whenever you deferred you occasion plea, you give up your rights to appeal.
