I can't tell you that the tactics for for the anti abortion people have changed dramatically in the last 10 years. It started out with what they call sidewalk counseling, which is quite literally one on one harassment and intimidation of the women seeking seeking the services at the clinics where they go up and say awful things to the woman and tell a lot of lies about the dangers associated the alleged dangers associated with abortions and certainly about the morality of the woman seeking the services. When that was ineffective when that when the pro choice community developed a very effective response to that by providing escorting, the violence increased dramatically. And we had just a tremendous surge of bombings and arsonists across the country through I believe it's about 84 through 86. Now, even this last year, we've had a bombing and in Belmont, but that's not their usual tactic now. And then what we saw after that when that became ineffective was Randall Terry was raised by the anti abortion leadership to his current role. And we started seeing these national blockades Wichita being what really brought them national prominence.

\$300. Now or who offered their services pro bono because they believe in the importance of this. The injunction that they obtained seemed to kind of thrown a loop in in the planning here, as well as the numbers just were not here. They didn't get the numbers. They had fewer activists on any day in Houston than they had in Baton Rouge. Oh goodness. And so they didn't have the people to do mass arrest the way that they wanted to. And frankly, let me qualify that mass arrests are a misnomer. Even in Wichita, there were no more than a couple 100 people ever ever jailed is just that implicit Wichita, you could get off on the trespass charge that night, and you can come out of the jail, come out to the site and get arrested the next day, get off that night and come back and and so the numbers escalated. There's actually been a very few number nationwide who have been willing to get arrested but even a smaller number here. Possibly because the injunction, the injunction has a contempt provision that if you violate it, you're going to be in contempt of court contempt in Texas as I understand it. So if you are found in contempt, the judge will set the penalty and the way for you to purge your contempt. In this case, the penalty was set at \$500 a sliding scale but But Judge O'Neill judge Eileen O'Neil who issued the temporary restraining order that set the injunction in place, set it on all the hearings at \$500. Plus you had to make a promise that you would not violate the injunction or the penalty side of that as opposed to The purging side of that is you spent six months in jail. Yeah, that's a whole lot stricter than most trespass, and you're not out on bond. While that's being considered while you're trying to purge your contempt, you're not out on bond. So we believe that this very strong injunction helped to to disrupt their plants. So what we saw was a lot of challenges to the constitutionality, the injunction, the injection was very broad, 100 feet away from from the property line of of any of the name clinics, you had to stay at least 25 feet away from the medical staff, or a patient attempting to approach the clinic very, very broad restrictions. And we believe that and so we saw a lot of focus going on, particularly at Planned Parenthood, on challenging the constitutionality. And that's currently before the Texas Supreme Court. What we saw in many of the other clinics was a reduced response due to that we had big numbers at several clinics, oftentimes. So just prayer rallies because we had them so well defended. West Loop was was probably the biggest exception. They had large numbers every day, and were challenged, I believe, on at least two or three occasions. By challenge. I mean, the line was was physically challenged. There was a strong police presence there. And and as I said, Everything stayed open the entire time.

Normally, people who are who are being held on contempt of court are released while the validity of the order that they're found in contempt of is being considered. So it's not any kind of response or predictor prediction of what the Texas Supreme Court will do with the actual injunction. On August 10, AIDS activist Martine Valeska Dominguez was beaten, stabbed and left for dead near Arriaga in the state of Chiapas. Police not only have failed to solve any of these cases, they have increased harrassment of gays according to local activists.
